IN THE NAME AND BY THE AUTHORITY OF THE STATE OF TEXAS:

THE GRAND JURORS OF TARRANT COUNTY, TEXAS, DULY ELECTED, TRIED, EMPANELED, SWORN, AND CHARGED TO INQUIRE OF OFFENSES COMMITTED IN TARRANT COUNTY, IN THE STATE OF TEXAS, UPON THEIR OATHS, DO PRESENT IN AND TO THE 371st DISTRICT COURT, OF THE SAID COUNTY

THAT TODD ANDREW CARLTON, HEREINAFTER CALLED DEFENDANT, ON OR ABOUT THE 3RD DAY OF AUGUST 2020, IN THE COUNTY OF TARRANT, STATE OF TEXAS, DID AS A MEMBER OF A GOVERNMENTAL BODY, TO-WIT: THE CARROLL INDEPENDENT SCHOOL DISTRICT BOARD OF TRUSTEES, KNOWINGLY ENGAGE IN AT LEAST ONE COMMUNICATION AMONG A SERIES OF COMMUNICATIONS THAT EACH OCCURRED OUTSIDE OF A MEETING AUTHORIZED BY TITLE 5 SUBTITLE A CHAPTER 551 OF THE TEXAS GOVERNMENT CODE AND THAT CONCERNED AN ISSUE WITHIN THE JURISDICTION OF THE GOVERNMENTAL BODY, TO-WIT: ACCEPTANCE/RECEIVING OF THE CULTURAL COMPETENCE ACTION PLAN, IN WHICH THE MEMBERS ENGAGING IN THE INDIVIDUAL COMMUNICATIONS CONSTITUTE FEWER THAN A QUORUM OF MEMBERS BUT THE MEMBERS ENGAGING IN THE SERIES OF COMMUNICATIONS CONSTITUTE A QUORUM OF MEMBERS AND KNEW AT THE TIME THE MEMBER ENGAGED IN THE COMMUNICATION THAT THE SERIES OF COMMUNICATIONS INVOLVED A QUORUM AND WOULD CONSTITUTE A DELIBERATION ONCE A QUORUM OF MEMBERS ENGAGED IN THE SERIES OF COMMUNICATIONS,

AGAINST THE PEACE AND DIGNITY OF THE STATE.
