<b>BE IT FURTHER RESOLVED,</b> the Ethnic Studies Advisory Committee overseeing the implementation of ethnic studies for all San Diego Unified students is comprised of at least 60 percent K-12 educators, college level educators, parents, students and community members.	
<b>BE IT FURTHER RESOLVED,</b> the Ethnic Studies Advisory Committee begin meeting immediately to develop recommendations as to how ethnic studies can be implemented and accessible to all students in the San Diego Unified School District throughout their K-12 educational experience.	
<b>BE IT FURTHER RESOLVED,</b> the Ethnic Studies Advisory Committee become an ongoing structure that will exist to ensure effective outcomes, teacher training and successful implementation. Recommendations will be implemented on an ongoing basis as they are approved by the Superintendent and Board of Education.
