**RFP # 18-21: Consultant to Implement Restorative Practices Protocols**

**THIS AGREEMENT**, made this 12<sup>th</sup> day of July, 2021, by and between Board of Education of Cecil County, also known as **Cecil County Public Schools (CCPS)**, acting herein through its Superintendent, hereafter called "Owner" and **Akoben LLC**, a corporation located at 364 E. Main Street, Middletown, DE 19709, hereinafter called "Contractor".


**WITNESSETH:** That for and in consideration of the payments and agreements hereinafter mentioned, to be made and performed by the OWNER, the CONTRACTOR, hereby agrees with the OWNER to commence and complete the services described as follows:

**Akoben LLC will Continue to Provide Consultant Services to CCPS per RFP #18-21:** Consultant to Implement Restorative Practices Protocols within Cecil County Public Schools. Contractor's proposal submittal assures coaching and support to all Cecil County Public Schools in conjunction with the National Institute of Justice (NIJ) grant. Particular attention to be focused on intensive site-based training for Restorative Practices. Consultant must include whole school professional development in the areas of restorative practices and cultural proficiency.

Consultant will work with CCPS on an as needed basis as determined and scheduled by CCPS Contract Manager. Consultant must coordinate training and oversight of practitioners. The 2021-2022 program includes seventy-one and three quarters (71.75) days of coaching and eighteen (18) days of training, each at the same rate of \$2,400.00 per eight (8) hour day for a total of eighty-nine and three quarters (89.75) days for a total of \$215,400.00. The Contract Period begins on or about July 1, 2021 and ends on June 30, 2022. The actual services performed at CCPS schools are scheduled by the CCPS Contract Manager. Contractor is to provide coaching and training in conjunction with the National Institute of Justice (NIJ) grant.

**HEREINAFTER**, called the Contract, for a total net annual amount of **Two Hundred Fifteen Thousand Four Hundred Dollars, (\$215,400.00)** and all related work in connection therewith; and at their own proper cost and expense to furnish all the labor, materials, supplies, superintendence, insurance and other accessories and services necessary to complete the project in accordance with the conditions and prices stated in the Proposal, the General Conditions and Special Conditions of the RFP Document and all related documents, and printed or written explanatory matter thereof, the specifications and contract documents therefore as prepared by the Board of Education of Cecil County, and as enumerated in the General Conditions, all of which are made a part hereof and collectively evidence and constitute the Contract.

**IN WITNESS WHEREOF**, the parties to these presents have executed this Contract in two (2) counterparts, each of which shall be deemed an original.
