OVERVIEW



In the spring of 2021, when we launched Parents Defending Education, a national nonprofit, parents started flooding our inbox with tips about disturbing trends they were seeing in the classrooms. An elementary school teacher in Pennsylvania had a book, "Not My Idea," in the classroom about "whiteness" being a pact with the devil. A teacher in Beaverton, Ore., told other teachers in "anti-racism" training to "evolve or dissolve." Around the country, one consultant, Panorama Education Inc. asks young students about their gender identity and sexuality. And an assistant principal in Ohio instructed students in a schoolwide email to lobby local leaders for legislation she supported.

Every week, we got scores of reports from distressed parents, students, teachers, grandparents, principals—just about anybody and everybody touched by the divisive teachings that have sprung from the controversial ideology called critical race theory.

At Parents Defending Education, we wondered how such a poison had penetrated our educational system so quickly and so deeply. We started investigating, following the money and connecting the dots. For this fourmonth investigation, we interviewed about 200 people and reviewed about 200 hours of trainings, school board meetings and "equity" team meetings. We filed 207 public records requests with public school systems under the Freedom of Information Act and other laws, scoured about 5,000 pages of documents and studied about 30 vendor databases.

While about one of three school districts, or 79 school districts, provided information, two of three school districts, or 128 school districts, have not yet responded with information.

What we discovered should shock any parent and taxpayer. We know we have just captured the tip of the iceberg. Send us a tip on anything we missed.

We call this our Consultant Report Card.



Some people call the network we have documented the "Woke-Industrial Complex." Others call it the "diversity industrial complex."

Whatever you call it, it's big money.



In August 2020, the NAACP launched a new education program, the Education and Civil Rights Initiative, in the University of Kentucky's Department of Educational Policy Studies and Evaluation to address "racial inequities." In late September, the initiative's executive director, Gregory Vincent, moderated an online meeting, "Critical Race Theory: Why It Matters and What it Teaches Us."

That day, the University of Kentucky announced senior administrators would be going through their own "anti-racist training,"

That day, in San Francisco, Lowell High School students were asked to submit anonymous comments on race and "inequity" on a school platform, Padlet. It was an assignment with a hidden agenda, because the school, like many other high-achieving schools with test admissions, has been under fire for years for its smaller percentages of black students, while being a school with a mostly minority student demographic. Its 2021-2022 student body was 71.8 percent minority — including 42.4 percent Asians, 15 percent multiracial, 12.5 percent Hispanic and 1.9 percent black — with 25 percent white and 3.2 percent from other races.

It was an assignment with a hidden agenda at the mostly minority school

as part of a first step in changing its "culture as a community united against systemic racism," led by Candice Hargons, an assistant professor and counseling psychologist "with a national reputation in the field of anti-racism training."

With the program well-entrenched now at the University of Kentucky, the Education and Civil Rights Initiative just needed to drum up something important: new business.

Their officials got just that on the afternoon of Inauguration Day, Jan. 22, 2021.

Instead of looking at the pipeline issues of school systems failing Black students at younger ages, critics had increasingly gone after the schools' test admissions, using the COVID-19 pandemic and the "equity" debate following George Floyd's killing, as an opportunity to eliminate test admissions and move to lottery admissions.

Now, on Inauguration Day, the activists got just the anecdote they needed to push their agenda. The comments deteriorated into sophomoric exchanges. Lowell Principal Dacotah Scott sent a video image to the Lowell community, stating: "The images and hateful words are part of historic acts of violence that have been committed time and again, and I will not tolerate it. This message is to whomever made these racist and anti-Semitic attacks on our community: I will pursue all means available to me to hold you accountable for your actions. Your words and actions have no place at Lowell."

In that February message, however, the school board announced it was initiating a "memorandum of understanding" with the Education and Civil Rights Initiative at the University of Kentucky College of Education in Lexington, Kentucky, "in collaboration" with the San Francisco NAACP, California NAACP, and National NAACP to "facilitate the creation of a Community Coalition to define and oversee an equity audit and result-

At a Lowell High School PTA meeting, a Lowell father asked if there would be an investigation into the incident. But without an investigation, the school board moved forward with a solution – and a consultant.

For a Feb. 2, 2021, school board meeting of the San Francisco Unified School District, an unlikely person – San Francisco school board member Alison Collins – coauthored Resolution No. 212-2A1, "In Response to Ongoing, Pervasive Systemic Racism at Lowell High School." She was about to get into a lot of trouble for her own racist tweets and messages against Asian Americans.

ing action plan to address the exclusion and ongoing toxic racist abuse that students of color, and specifically Black students, have experienced at Lowell High School since the school's creation."

Sure enough, on June 16, 2021, the San Francisco Unified School District signed a contract to pay the Education and Civil Rights Initiative \$15,000 to conduct a "Lowell High School equity audit" for the 2021-2022 school year.

The plan included three phrases:

PHASE 1

Establish an Action Committee, Distribute audit surveys, Hold Focus Groups to address admission issues at Lowell High School and racial bullying (particularly increase in incidents against Asian Americans).

PHASE 2

Using data from surveys & focus groups prepare action plan & recommendations. Conduct a policy review. Develop training plan recommendations to address growth areas identified in the equity audit and policy review.

PHASE 3


Develop a community-based peer review process to ensure the work progresses over time. Continued on-demand support and consultations.

In April 2021, the NAACP's Education and Civil Rights Initiative <u>held a webinar</u> on critical race theory and ethnic studies.

That spring, the Education and Civil Rights Initiative held its <u>first national conference</u> in early May 2021, with K-12 education on the agenda. The speakers included Adora Nweze, education committee chair at the NAACP. The schedule had <u>K-12 sessions</u>, including "Implementing Anti-racist Education Across the Disciplines," exploring "what antiracist teaching looks like in practice in K-12 educational settings." The moderator was Sahara Alameh, an academic at the University of Kentucky.

The local Lowell High School "Community Coalition" had a Sept. 1, 2021, deadline to issue a report on its unclear results. But the NAACP's new consulting operation, Education and Civil Rights, could report a victory in its launch. It had gotten in the door at one of the United States' premier high schools.





Early February 2021 saw new activism in America's K-12 schools with "Black Lives Matter at Schools," a new national movement, rolling out at schools across the country.

It even took root in Ames, Iowa, where parents were shocked by the new activism in the classroom, including teaching the "13 Guiding Principles" of the movement. As it turns out, Ames is an archetype of a school district that went woke.

The new activism had been a slow creep over the past five years, based on the time-line in a 23-page report the school district had to provide to the lowa House Oversight Committee after angry parents called state legislators. What wasn't in the timeline: the consultants that had come into the district with divisive ideas.

A few months later, in January 2017, Ames Community School District officials signed up Spikes and his colleague, Katy Swalwell, a white professor, to a three-year contract to educate teachers and administrators on increasing "cultural competency." Over the next five years, the Ames Community School District doled out an estimated \$232,036 to the two consultants and another colleague, Erin Meeks, in payments they collected from 2017 through 2021, according to documents released to Parents Defending Education in response to public records requests.

Swalwell had a controversial point of view. She cohosts a podcast, "Our Dirty Laundry," which she describes as an "irreverent dive into the history of white women's complicity in white supremacy." She describes the podcast as "Stories of White Ladies Making a

In the fall of 2016, Ames Community School District officials had recruited an outside consultant, Daniel Spikes, a Black academic at local Iowa State University, to examine "racial disparities in educational outcome."

Mess of Things & How We Need to Clean Up Our Act." The official website invites listeners with an unusual hook based on guilt, saying, "Join two longtime white lady friends as they reckon with the history of white women with humor and rage...and figure out what it means for their obligations today."

On her website, Swalwell promotes the "Spikes & Swalwell Consulting Team," noting she "works closely with Dr. Daniel Spikes to co-facilitate sustained professional development on critical consciousness, implicit bias, and instructional, curricular, and structural changes to work towards equity and justice in education."

"Rates are on a sliding scale," she notes, adding, "Katy and Daniel are typically available for booking 6-9 months out."

Year one, in 2017, Spikes and Swalwell trained principals with a program, "Critical Consciousness training for staff."

Around then, in early 2017, another local consultant, Abdul Muhammad, helped organize a local march with Black Lives Matter lowa founder Sean Carlton-Appleton, who decried "soft racism" in the area. Years later, he registered Monarch Training and Development, LLP, based in Ames, Iowa, as a new business.

"According to a press release for the event," the Ames Tribune reported, "those issues include the recent Ames school report card that highlighted significant racial disparities between black and white students, racial epithets being used at lowa State University football games, swastikas being posted around the ISU campus and stories of subtle and blatant racism in Ames. Although the march

is attempting to address some issues that have been experienced at ISU, Carlton-Appleton said it is not an ISU organization."

With the Black population in Ames at about three percent, Muhammad acknowledged that meetings mostly had white participants. In the local media article, Muhammad said the community hadn't had a significant racial event. "Just because we haven't had that, it doesn't mean that there aren't issues that affect black families and black lives in Ames, Iowa."

In year two, 2018, Swalwell and Spikes expanded their work, "Critical Consciousness: Year Two," to coaches and certain building staff. In August 2018, over 50 Ames staff attended a conference, "Summit and School Culture and Climate." In August 2018, another consultant, Paul Gorski, addressed teachers at a kick-off breakfast.

Year three, 2019, the school district hired a director of equity, Anthony Jones, and it rolled out the "Critical Consciousness" training to all staff.

Spikes and Swalwell brought in a colleague, Erin Meek, a queer identity studies professor and "equity scholar" at lowa State, to conduct an "equity audit." They used all of the buzzwords of an audit to not "blame students and families" through a "deficit-based view" of academic shortfalls for Black students,

but rather took an "asset-based view" that "assumes responsibility for those inequities and explores the ways in which schools create and perpetuate inequity in an attempt to disrupt it."

On Sept. 30, 2019, the school district's Twitter account @ACSD_News tweeted out photos of a training with the message, "Today, over 130 teachers and staff engaged in critical consciousness training with Dr. Katy Swalwell and Dr. Daniel Spikes. The conversations are always rich and challenging with the outcomes impacting all of our students. #AmesCSD."

That year, the school district completed an "equity audit" for Ames High School and Ames Middle School. Swalwell hosted an "Amazing Education Podcast" on "Critical Consciousness. Part I. Part II." She developed "Building Capacity Teams."

The program expanded into a "Critical Consciousness Family Learning Series."

The year 2020 was called "Critical Consciousness: Year Three," with "over 150 staff members" who "participated in monthly professional development."

"Building-level teams formed," with Ames High School staff "participating in implicit bias training." District officials participated in weekly administrative meetings with "equity learning." Ames Middle School started teaching a "Critical Consciousness class."

The Swalwell and Spikes consulting team started a "Critical Consciousness Family Learning Series," as well as "LGBTQ+ professional development training." Swalwell hosted another "Amazing Education Podcast" with the director of equity, Anthony Jones, on "racial inequity. Part I. Part II."

The morning of Monday, Jan. 20, 2020, Ames High School in Ames Community School District hosted a 2-1/2-hour event called, "Understanding Implicit Bias WORKshop," led by the other local consultant, Abdullah Muhammad, the founder of Monarch Training and Development, for a \$3,500 fee.

According to Invoice #200302, Muhammad charged \$15.56 per hour per participant, for a total bill of \$3,500 for 90 participants. He waived a \$700 fee for a half-hour time extension and included his three-and-a-half hours for event preparation, planning meetings and post-session debrief.

The contract noted the "WORKshop" would include "experience-sharing" and "individual reflection." It said: "Host understands that the format of the WORKshop is designed to be a mixture of content-delivery methods including lecture, group discussion, experience-sharing, individual reflection, and preliminary action planning.

The next year, Black Lives Matter at Schools became the subject of statewide controversy, as "Black Lives Matter at School Week of Action" was launched in Ames, after years of consultants priming the pump.

On Jan. 22, 2021, the school district announced its "Black Lives Matter Week of Action" on Facebook, and that <u>did not sit well</u> with parents.

One of the comments posted: "Will the action include riots?"

Among the proponents of the controversial material? The consultant, Muhammad, spoke at an Ames board meeting to support Black Lives Matter Week of Action in the school district. Not long after, a <u>local media report published</u> a screenshot, allegedly written by his wife, <u>Jean Muhammad</u>, the student and family advocate in Ames High School since 2017.

In the screenshot, she allegedly wrote:

"Want a quick glimpse into *our* interracial marriage?

Me-Going to give Abdullah a kiss goodnight, 'Okay, I'm going to bed...'

Abdul- singing in his reggae voice, 'I say we kill da white people...'

Me-Laughing hysterically, 'Okay, love you."

Muhammad didn't comment about the post.

Later, in a two-hour meeting of the House Government Oversight Committee, Anthony Jones, director of equity for the Ames Community School District, <u>defended the week</u>, saying: "What we are doing is bringing ideology into the conversation, but not just ideology, we are also bringing people."


He concluded: "If that is political, then yes, it is political."

On June 17, 2021, the controversy still brewing, Katy Swalwell registered a new consult-

ing firm, Past Present Future Consulting & Media, LLC, based in Des Moines, Iowa, with the Iowa Secretary of State, according to the company's official filing. In her bio, she noted that, as a lead equity specialist for the Equity Literacy Institute, she has "facilitated workshops, helped develop curriculum, and provided other supports for schools across the United States and Canada."

This included, of course, one school district in the United States: Ames, Iowa, now full-on woke.

In late 2020, New York City's Dalton School drew headlines after trainers from Pollyanna, a 501(c)3 nonprofit, led mandatory training that included "forcing a Jewish student to play a racist cop" in a science class exercise and teaching an art class on "decentering whiteness." Seventh and eighth-graders were required to examine their lives through the perspective of "intersectionality," a left-wing theory that posits that a person's social and political identities combine to create different modes of discrimination and privilege. The takeaway here, of course: the students must come to grips with their "white privilege."

As of 2020, Pollyanna was spreading the Woke Gospel in 60 schools around the nation, including cream-of-the-crop Manhattan private schools—The Brearley School, The Dalton School, Horace Mann School, The Spence School and the Hunter College Elementary School, as well as Harvard-Westlake School in Los Angeles. Indeed, the Woke-Ed Machine has penetrated the National Association of Independent Schools, whose membership includes religious and secular private schools.

While our investigative reporting project, Consultants Report Card, focuses on public schools, we wanted to chronicle the phenomenon of indoctrination in private schools, because they are a key target of activists, educators and consultants indoctrinating children.

Consider St. Luke's School in New Canaan, Connecticut. In 2002, Mark Davis arrived from the elite Phillips Exeter Academy, to be headmaster. Just an hour's drive northeast of Manhattan, St. Luke's drew well-heeled families to its "Hilltop," with its secular mantra of "Enter to Learn, Go Forth to Serve." After taking a sabbatical to learn the Vipassana tradition of Buddhism, commonly known as "insight meditation," Davis returned in April 2019 determined, with the help of a handful of activist teachers and parents, to bring his energized Woke politics to the school in his charge.

In June 2020, Davis hosted the second Political Discord & Civil Discourse assembly, "Student Leadership: Bringing Civil Discourse to Life," featuring a St. Luke's parent, former President George W. Bush spokesman Ari


[Pollyanna] led mandatory training that included "forcing a Jewish student to play a racist cop" in a science class exercise and teaching an art class on "decentering whiteness."

Fleischer. Later—after Woke adherents criticized Davis for allowing a Republican viewpoint to be voiced at St. Luke's—he would apologize for Fleischer's appearance.

Increasingly, parents started noticing staff activism that made them uncomfortable. At one point, Carrie Meatto, a Spanish teacher in the Upper School since 2017, required her students to write letters to governments in Central America and Latin America, advocating for the legalization of abortion, among other issues.

In early 2020, in the school's Forese Fire-place Commons, school officials welcomed controversial author Robin DiAngelo to talk about her book, White Fragility. Davis didn't allow parents to ask questions directly of DiAngelo. They had to write their questions on index cards, hand-chosen by Liz Perry, an English teacher and Head of Upper School, and Amber Berry, another staffer.

That spring 2020, as families were isolating during the early weeks of the COVID-19 pandemic, a teacher facilitated a parent event and told parents to create "bubbles"

based on identity. By fall, after the killing of George Floyd, the teachers were full throttle with their "anti-racism" exercises. The first week of schools, students had to play the "Factuality Game," charged \$50 each to roleplay identities they were assigned, from "woman of color" to transgender men. Black Lives Matter stickers on her classroom bulletin board, teacher Jennifer Pokorney one day told students they were going to play charades, acting out current events.


One team got "mass shootings." A team of two boys got "abortion." The boys objected. Pokorney insisted they do it. School officials swept it under the rug. This isn't clear. Parents complained but nothing happened.

That fall, in late October 2020, the school held one of its regular "Town Meeting" events. The presentation, during Asexual Awareness Week, or "ACE Week," encouraged children to know the differences between "demisexual" and "asexual." One elementary school student had to fill out a nametag with her preferred pronoun.

Just before the 2020 presidential vote, Davis held a "Drop-in" session and lamented his choice for president hadn't won in 2016. Some parents shook their heads.

Parents quietly chronicled the indoctrination they had been witnessing. Now, "Affinity Groups," not straight-up education, were the norm at the school they loved. Some parents pulled students from the school but many remaining parents continue to be frustrated.



What is Panorama Education Inc.?

In an article in February 2013, Yale student Aaron Feuer described his decision to create Panorama Education. The article described the organization as an "education analytics company," and said it was "snowballing," working in six states.

The article noted:

"Every school in America should be using this," Feuer remarks with a wry smile.

That year, Panorama Education <u>emerged</u> nationally as a company that conducts

"surveys of students, parents, teachers, and staff" and "analyzes this data and presents teachers and administrators with clear and constructive feedback that they can use to improve their teaching and their schools."

In October 2013, the <u>Boston Globe reported</u> that Facebook founder Mark Zuckerberg's Startup: Education, Jeff Clavier's SoftTech VC [Venture Capital], Google Ventures, actor Ashton Kutcher's A-Grade Investments and Yale University provided \$4 million in seed funding to the company.

In late 2013, legal experts at Fordham Law School raised concern about the ability of companies like Panorama in protecting student data in a research paper, "Privacy and Cloud Computing in Public Schools."

On June 10, 2014, Panorama Education Inc. was incorporated with the state of Delaware, according to a copy of the filing.

On June 13, 2014, then-Yale University undergraduate student Alexander Tanner registered Panorama Education Inc. with the state of Massachusetts, according to the filing (which stated that the company was incorporated on April 2, 2012, in Delaware).

Fellow Yale student Aaron Feuer was listed as the president, and Tanner was listed as the secretary. Another student, Dan Carel, was involved with the company's founding.

For the fiscal year ending Dec. 31, 2014, Panorama Education said it "provides survey software/services to K-12 schools," according to the company's 2015 filing with the state of Massachusetts. The filing stated there were 2,807,212 shares of PWP class of stock authorized by articles of organization or amendments, with all of the shares issued and outstanding, and 14,034,212 shares of CWP class of stock authorized, with 8,562,876 shares issued and outstanding.

In the <u>next year's 2106 filing</u>, new directors were listed as Andrew Parker and Jed Smith.

In late 2017, soon after graduating, Feuer announced Panorama Education had raised \$16 million in Series B funding, led by the Emerson Collective, a grantmaking company based in Palo Alto, California, with participation from several investment firms: Spark Capital, Owl Ventures, SoftTechVC (now Uncork Capital), and the Chan Zuckerberg Initiative, cofounded by Facebook founder Mark Zuckerberg and his wife, physician Priscilla Chan.

In the 2017 filing, the company added Katie Mallett as the chief financial officer and Amit Patel, based in San Francisco, and Ross Jensen, based in Palo Alto, California, as directors.

The company said it was "serving 10 percent of America's students" and would "use the funding to expand its tools that help school districts develop students' social and emotional skills, promote family engagement with school, and increase college readiness."

Panorama Education's <u>2018 filing</u> included continued stock shares.

According to a <u>press release</u> from early 2019, its staff includes a "team of former educators, engineers, designers and researchers dedicated to helping K-12 schools and districts improve student outcomes."

Later that year, in October 2019, Feuer, the company's cofounder and chief executive officer, announced on Twitter that Panorama Education had launched a new "Equity and Inclusion Survey" to "elevate #studentvoice on diversity, equity, and inclusion in school."

In its 2019 filing with the state of Massachusetts, Panorama Education continue to list its stock shares.

In the company's 2020 filing with the state of Massachusetts, signed March 26, 2021, Tanner was listed as the registered agent. The company had an all-male slate of directors. Feuer was the president. Tanner was the secretary. The other directors listed were Amit Patel, Ross Jensen and Alex Finkelstein.

The company said it had 31.7 million shares of "CWP" class of stock, authorized by its articles of incorporation or amendments, and it had issued 9,182,574 shares.

It said: "With a best-in-class data analytics platform, Panorama develops advanced technologies that empowers educators to foster improved social-emotional learning, school climate, and student engagement."

Today, Panorama said it supports "more than 9 million students in 11,500 schools nationwide," and is "dedicated to ensuring

educators can provide the highest-quality education for every student to succeed."

In early September 2021, as Panorama was increasing its contract with Fairfax County Public Schools to \$2.4 million for a multi-year "screener," it raised \$60 million in a Series C round of funding led by General Atlantic.

TechCrunch.com reported:

Existing backers Owl Ventures, Emerson Collective, Uncork Capital, the Chan Zuckerberg Initiative and Tao Capital Partners also participated in the financing, which brings the Boston-based company's total raised since its 2012 inception to \$105 million.

Panorama declined to reveal at what valuation the Series C was raised, nor did it provide any specific financial growth metrics. CEO and co-founder Aaron Feuer did say the company now serves 13 million students in 23,000 schools across the United States, which means that 25% of American students are enrolled in a district served by Panorama today.

In Purchase Order 00000405526, dated March 3, 2016, Fresno Unified School District paid Panorama Education \$27,000 to provide support to the school district "survey initiatives relating to the CORE waiver entered into" by the school district

and five other public school districts in California, assisting "online students, staff and family survey programs."

The services were from Feb. 11, 2016, through June 30, 2016.

PURCHASE ORDER

In Purchase Order 00000455301, dated Feb. 24, 2017, Fresno Unified School District paid Panorama Education \$80,000 to provide support to the school district "survey initiatives relating to the CORE waiver entered into" by the school district and five other public school districts in California, assisting "online students, staff and family survey programs."

The service was for six months from Jan. 25, 2017, through June 30, 2017.

PURCHASE ORDER

In Purchase Order No. 00000502396, dated Nov. 7, 2017, Fresno Unified School District agreed to pay Panorama Education \$80,684 to provide the same services as the year before.

The service was for one year from July 1, 2017, through June 30, 2018. The year before the school district paid the same amount for six months of service.

PURCHASE ORDER

In Purchase Order No. 00000548067, dated Aug. 16, 2018, Fresno Unified School District entered into another agreement to pay Panorama Education \$80,000 to provide support to the school district for the same services as the year before.

The purchase order was from July 1, 2018, through June 30, 2019.

PURCHASE ORDER

The next year, in Purchase Order No. 00000598873, dated Aug. 28, 2019, Fresno Unified School District agreed to pay Panorama Education another \$80,000 once again to provide support to the school district for the same services.

The purchase order was marked "(Bundled Contracts)."

The purchase order was for the next year from July 1, 2019, through June 30, 2020.

PURCHASE ORDER

In Purchase Order No. 00000600795, dated Oct. 3, 2019, Fresno Unified School District paid \$5,000 for a site license agreement for its Prevention and Intervention Department from Oct. 1, 2019, through Oct. 1, 2020, for the purpose of "survey administration, analysis and reporting."

The purchase order noted: "The vendor must maintain compliance with Family Educational Rights and Privacy Act (FERPA) and the Children's Online Privacy Protection Act (COPPA). This contract prohibits the sharing of metadata, keystroke data, time & place, account information, and student information including but not limited to; name, grade, school name, test scores, etc. with any third party."

The order also said: "All FUSD information/ data collected, generated, or stored during the course of this contract must be destroyed upon conclusion or termination. If Vendor experiences a security breach concerning any education record covered by this contract, then Vendor will immediately notify the district and take immediate steps to limit and mitigate such security breach to the extent possible."

The services included:

"Access to Platform and Support (as defined in the Terms and Conditions): Survey administration, analysis and reporting."

"Student culture, climate, and social-emotional learning measures."

"Includes implementation training and setup."

PURCHASE ORDER

In Purchase Order No. 00000741322, dated July 13, 2021, Fresno Unified School District paid \$85,000 for Panorama Education to "provide support" for the "survey initiative relating to the core waiver entered into" by the school district, assisting "on-line [sic] students, staff and family survey programs." The contract was being handled by the school district's equity and access department. It was approved by the school board on June 16, 2021. The effective dates for the order was July 1, 2021, through June 30, 2022.

Panorama Education <u>featured the school</u> <u>district on its website</u>.

PURCHASE ORDER

Two weeks later, in Purchase Order 00000691176, dated July 27, 2020, Fresno Unified School District agreed to pay another \$85,000 for more services, with a line in

the purchase order marked, "BOE 06/17/20 A-4 (Bundled Contracts).

This order was for support to the school district's "survey initiative relating to the CORE waiver entered into" by the school district, assisting "on-line [sic] students, staff and family survey programs" — the exact same language as the earlier purchase order, dated July 13, 2020.

The effective dates for the order were also the same.

Moreno Valley Unified School District

PURCHASE ORDER

On Feb. 21, 2019, Moreno Valley Unified School District issued Purchase Order No. CPO19-00568 to pay Panorama Education Inc. \$89,000 for providing "school climate and parent engagement survey administration, analysis, reporting, and professional development services," between Feb. 13,

2019, and Feb. 12, 2021. The board approved contract No. A-18/19-3092 on Feb. 12, 2019.

While promoting the '2019 Annual Climate and Satisfaction Survey' on its website the school district told the community: "We are currently surveying MVUSD families in order to gain insight into your perception of our school and district effectiveness. To ensure we continue to provide high quality, rigorous learning experiences that meet the needs of our learners and prepare them for college and career, we need your feedback. We want to know what you think. During this month, students will also be asked to complete an online questionnaire that encourages them to reflect on their own mindsets and approaches to learning."

It reassured survey respondents: "We have partnered with Panorama Education to conduct our 2019 Annual Climate and Satisfaction Survey. Panorama safeguards your privacy, keeping your responses confidential."

It pitched the survey as easy, taking "between 15-20 minutes to complete," and helpful, as an "invaluable source of information for us as we work to make our schools and district as good as they can be."

AMENDMENT TO CONTRACT

In an "Amendment to Contract," dated June 24, 2019, the school district added another \$101,000 to its contract, buying a "workshop for training" for staff, at a cost of \$3,000 per two-hour workshop. A note to the district said: "...we need to do an amendment to add the services to train staff on how to use the results of the survey that was conducted in March."

PURCHASE ORDER

In Purchase Order CPO20-00534, dated Jan. 7, 2020, Moreno Valley Unified School District agreed to pay Panorama Education \$12,000 to "add training workshops for staff," as part of its school climate survey.

PURCHASE ORDER

In Purchase Order CPO20-00572, dated Jan. 27, 2020, Moreno Valley Unified School District agreed to pay Panorama Education \$54,000 for a "Professional Consultant Agreement" to "provide district walk-through workshops to support district leaders."

PURCHASE ORDER

In Purchase Order CPO20-00644, dated Feb. 26, 2020, Moreno Valley Unified School District agreed to pay Panorama Education \$89,000, as part of its agreement to "conduct a school climate survey and training workshops for staff." The purchase order was for Agreement No. A-18/19-3092.

PURCHASE ORDER

In Purchase Order CPO21-00549, dated May 24, 2021, Moreno Valley Unified School District agreed to pay Panorama Education \$95,000 for this line item: "Panorama surveys administration will gather student, teacher, staff and parent data to analyze and report to the MVUSD TIA [Technology, Innovation and Assessment] Dept. and Student Services Dept. The data will be used to provide school and community climate to MVUSD." The purchase order was for Agreement No. A-20/21-3752.

Panorama Education featured its work with the school district among its <u>"success stories."</u>

HAWAII

Hawaii Department of Education

CONTRACT

On March 19, 2021, Panorama Education Inc. chief executive officer Aaron Feuer signed a contract worth a total of \$1,451,110.50 with Christina Kishimoto, superintendent of education for the state of Hawaii, to "provid [sic] and administer a Student Perception Survey."

Panorama promoted the work among its <u>"Success Stories."</u>

ILLINOIS

Woodbridge School District 68

SERVICE ORDER

In a service order signed June 10, 2019, Woodbridge School District 68 in Illinois agreed to pay Panorama Education \$82,800 total for several items:

- "Three-years [sic] of access to Panorama Student Success, Survey Platform and Standard Support for Woodbridge District 68," covering 3,000 students and including "Student and school integrated trackers, data dashboards and early warning systems with customizable reports filters."
- "Project Management," including coordinating a "rollout of Panorama reports to district educators."
- Professional Development, including one virtual workshop per year for school-based staff to "support implementation, knowledge of the Success and Survey platforms."

The school district's assistant superintendent, Greg Wolcott, and the Panorama's vice president of finance, Katie Mallett, signed the contract. Panorama Education promoted the school with a dedicated page on its website and a video with the principal saying, "We gotta get each individual kid's heart if we're gonna get their heart." A teacher said they were using the Panorama Education data for student "emotional regulation."

The goal identified: to create "good people."

INDIANA

Indianapolis Public Schools

In a page dedicated to the school district, featuring "success stories," Panorama Education wrote: "How Indianapolis Public Schools Is Keeping Students Learning at Home." The write-up said: "When school closures due to COVID-19 began, Indianapolis Public Schools (IPS) took swift action to set up at-home learning for its 32,000 students and 2,600 caring educators with Panorama survey data." It added a video conversation with the school district's director of strategy.

KANSAS

SERVICE ORDER

On May 14, 2020, Shawnee Mission School District in Kansas signed a service order for \$54,050. The total includes \$42,000 for a license fee for Panorama's social and

emotional learning platform and support. That fee includes "measure administration, analysis and reporting," including social-emotional learning measures.

The total also includes \$6,300 for project management, \$750 for one one-hour to three-hour virtual workshop, \$5,500 for an on-site "data inquiry" workshop, totaling \$12,050.

In the virtual workshop, Panorama Education said it "prepares customized workshops for a variety of stakeholder groups, including teachers and staff, school principals, school boards, and parents to build a culture of feedback in your schools."

School boards typically must approve a Panorama Education contract.

The fine print said: "Panorama cares deeply about privacy, and we recognize that it is important to educators, students, and parents we serve."

Panorama Education <u>featured the school</u> district on its website.

INVOICE

In Invoice No. 678, dated July 5, 2016, Panorama Education billed Maine School Administrative District #72 another \$2,000 for the same services.

INVOICE

In Invoice No. 1198, dated July 1, 2017, Panorama Education billed Maine School Administrative District #72 another \$2,000 for the same services.

INVOICE

In Invoice No, 1875, dated July 3, 2018, Panorama Education billed Maine School Administrative District #72 a slightly higher amount of \$3,500 for the same services as the years earlier.

INVOICE

In Invoice No. 3757, dated July 31, 2019, Panorama Education billed Maine School Administrative District #72 a price bump of \$4,000 for the same services as the years earlier.

In a report, they explained that the school district's communications department had conducted "climate" surveys in 2014-2015 and 2016-2017.

In spring 2018, the report said, that "it was determined that we should deliver climate surveys again this year." The school district "conducted a pilot with Panorama's survey to consider partnering with Panorama for future school climate surveys," staring in the 2018-2019 year and continuing through 2019-2020.

That year, it said, "Portland Public Schools is collaborating with Panorama Education to gather student and family feedback in order to give teachers and administrators actionable data points that will help them improve student experiences across the district."

In 2019, Panorama surveyed students, teachers, and parents in in 102 schools in the school district. Related to "Background Questions" at Alliance High School at Meek Campus, Panorama shared information from 15 respondents in ninth and tenth grades. Five students responded they were a "Girl / Woman." Nine said they were "Boy / Man." One student responded, "Nonbinary."

To a question, "Are you transgender?" Fourteen said, "No, I am not transgender." One did not respond.

The next questions was: "How do you describe your sexual orientation?" Nine students said, "Heterosexual / Straight." Zero students said "Lesbian," "Bisexual / Pansexual," "Queer,"

or "Questioning / not sure." One student said, "Gay."

Students also described their feelings and "Sense of Belonging."

This data collection isn't limited to students.

Also, 4,191 parents in Portland Public Schools said they were "Heterosexual / Straight," and 16 parents said they were "Questioning / not sure." Of the teachers and staff, 67 said they were "Bisexual / Pansexual."

There are more recent results but for the sake of protecting privacy that Panorama doesn't protect, we are not including more current information currently.

On its website, Panorama Education bragged that Ogden High School increased its graduation rate to 95 percent after Ogden School District hired Panorama Education.

It wrote: "For educators in Ogden School District, the effective use of a multi-tiered system of supports (MTSS) is central to their mission of maximizing educational opportunities for all students."

Panorama Education shared a colorful profile about the school district, as it did with other school districts, writing, "Located 30 miles north of Salt Lake City at the foot of the Wasatch Mountain Range, Ogden School District serves 12,300 students in an urban environment. The nearby peaks could very well symbolize both the towering challenges and goals of the district. Nearly eight out of 10 students receive free or reduced-price lunch—some of the highest rates in Utah—and schools face high instances of chronic absenteeism, high-school dropouts, teenage pregnancy, and suicide."

It wrote: "Despite these odds, by 2020, the district strives to achieve an 88 percent graduation rate (up 20 percentage points) and an on-track literacy rate of 50 percent (up 15 percentage points)."

The school district is using emergency COVID relief funds signed into law on March 20, 2021, after Congress set aside about \$13.2 billion of the \$30.75 billion allotted to the Education Stabilization Fund through the Coronavirus Aid Relief, and Economic Security (CARES) Act for the Elementary and Secondary School Emergency Relief Fund (ESSER Fund). The so-called ESSER Fund was designed to "address the impact that COVID-19 has had, and continues to have, on elementary and secondary schools across the Nation."

The funding source was "Levy Public Services (1208)."

What is the National Equity Project?

The National Equity Project, based in Oakland, Ca., was <u>established</u> on April 13, 1995, as a nonprofit with the California Secretary of State, as the Bay Area Coalition of Essential Schools.

In July 2010, it registered a new name, National Equity Project. It describes itself as a "leadership and systems change organization committed to increasing the capacity of people to achieve thriving, self-determining, educated, and just communities." It says

its mission is to "transform the experiences, outcomes, and life options for children and families who have been historically underserved by our institutions and systems."

In February 2021, the <u>company registered</u> Na'ilah Suad Nasir as the chief executive officer and Gloria Lee as the secretary. The chief financial officer was Brian Stanley and the agent for service was LaShawn Route-Chatmon.

In its 2020 IRS Form 990, documenting its finances, the National Equity Project had \$8.8 million in total revenue in 2020, an increase from \$7.4 million the year before.

Its executive director, LaShawn Route-Chatmon earned \$211,133, plus a \$25,045 bonus, totaling \$236,178 in compensation. Seven other staffers earned between \$116,783 to 167,594, along with attractive bonuses.

What is Pacific Educational Group Inc.?

In 1992, Glenn E. Singleton, a former lvy League admissions director, established Pacific Educational Group, "committed to achieving racial equity in the United States and beyond." The company was registered as Pacific Educational Group Inc., on Jan. 4, 1994, with the California Secretary of State. The 2020 filing listed Singleton as the chief executive officer, based in San Francisco. Christine Lim is the secretary, based in Oakland, Ca., and Adrienne Cecile Edmands is the chief financial officer.

Marking 25 years in 2018 in the "race and equity in education" business.

A graduate of the University of Pennsylvania, he earned his master's degree from the Graduate School of Education at Stanford University, according to <u>an official bio</u>.

In 2006, he wrote the book, "Courageous Conversations About Race: A Field Guide for Achieving Racial Equity in Schools." Later, he published the book, "More Courageous Conversations About Race."

On its <u>website</u>, Courageous Conversation says it is "providing training, coaching and consulting services for millions of racial equity leaders around the world."

Pacific Education Group describes itself as an "award-winning protocol for effectively engaging, sustaining and deepening interracial dialogue." Through its "Framework for Systemic Racial Equity Transformation," the group's staff members say they "help individuals and organizations address persistent racial disparities intentionally, explicitly, and comprehensively" and "engage in sustained partnerships featuring training, coaching and consulting with organizations to transform beliefs, behaviors and results so people of all races can achieve at their highest levels and live their most empowered and powerful lives."

In 2015, EAGnews obtained a list of school districts that contracted with Pacific Educational Group, and 42 districts responded to a query about how much they paid Pacific Educational Group over the past five years. The total amount spent was \$3.9 million between 2010 and 2015.

Pittsburgh Public Schools spent \$586,300 over a four-year period for Pacific Educational Group, the largest amount spent. From 2010-2011, the school district spent \$231,000; from 2012-2013, it spent \$183,200; and from 2013-2014, it spent \$76,000.

In late September 2016, Singleton was a featured speaker at <u>an annual conference</u> of the National School Boards Associations and Council of Urban Boards of Education in Miami, Florida, at the Four Seasons Hotel. Singleton led a three-hour-and-15-minute "Leadership Training Workshop," called, "School Board Members, Step to the Front on Achieving Racial Equity!" The workshop description said Singleton "will engage participants in a Courageous Conversation which will leave board members poised and practiced to take action in their districts actions that will achieve racial equity—and better able to confront challenges related to existing class, gender, and linguistic inequities."

Cornel West spoke at the conference.

What services does the Pacific Educational Group Inc. offer?

The National Summit for Courageous Conversation says it is "uniquely designed for educators, civic and community leaders, and other professionals who are committed to elevating individual and organizational racial literacy and consciousness to eradicate racial disparities that are predictably evident in achievement."

The organization says the summit is "our venue for bringing together the most promising and effective racial equity leadership voices, practices and results for examination and broader dissemination across the United States and globally."

Other services include:

The company's <u>services</u> include engaging in "sustained partnerships with our clients that center on training, coaching and consulting to transform beliefs, behaviors and results so people of all races can achieve at their highest levels and live their most empowered and powerful lives."

- ▶ It sells a "variety of <u>seminars</u>" on "various topics." It offers "scheduled programming" and "customized seminars for clients interested in more specific areas related to racial inequity, such as: racial inequities in education, corporate work environments or local structures such as city-level government."
- trying to navigate through a current, internal issue or concern within their organization," helping to "identify standards for equitable solutions as well as existing areas of interrogation that they may not have considered." The website notes: "Structure of this service is highly dependent on the unique circumstance of the client. Frequency of coaching sessions and expected goals are developed in collaboration with each client at the start of the coaching relationship."

▶ It sells <u>"consultation,"</u> to "launch professional and organizational change." The service "provides us the opportunity to navigate any predictable and emerging resistance alongside you, while redesigning practices and policies to create a more racially equitable, diverse and inclusive space for your company or organization." It also sells the service on a "caseby-case basis to clients who may be seeking help with unique situations that require more nuance."

What K-12 work has Pacific Educational Group, Inc. done?

CALIFORNIA

Acalanes Union High School District

In August 2019, the East Bay Times wrote that Acalanes Union High School District Associate Superintendent Amy McNamara "contacted Pacific Educational Group of San Francisco three years ago."

The school district included details and a video on its website.

California Department of Education

According to a copy of meeting minutes, in 2010, in partnership with Jack O'Connell as the State Superintendent of Public Instruction, the California Department of Education reported that Edison Charter Academy Principal Edward Winchester "informed the Members that the charter's management

was taking a closer look at data, specifically towards subgroup data, and was contracting services from Glenn Singleton of the Pacific Educational Group in an effort to meet the needs of the school's African American students as well as for professional development for teachers, and was using benchmark assessments, mapping standards, and creating pacing guides to do so."

Lodi Unified School District

In 2008, a <u>local columnist wrote</u> "Good riddance, Pacific Leadership Group," after the Lodi Unified School District decided to not renew its contract.

Monterey Peninsula Unified School District

On Jan. 22, 2019, according to the meeting minutes from a board retreat of the Monterey Peninsula Unified School District, the board unanimously ratified a contract "not to exceed" \$56,600 with Pacific Educational Group for Racial Equity Seminars in 2018 and 2019.

Oakland

The school district's database of vendors included a Contract with Pacific Educational Group to "provide its Courageous Conversations About Race Certificate Program training, as described in the Scope of Work, incorporated herein by reference, to Board of Education District 3 Director, Jumoke Hinton Hodge, for the term December 15, 2017 through January 30, 2018, at a cost not to exceed \$1,500."

San Leandro Unified School District

A <u>school district PDF</u> describes the school district as a "PEG Partner Since 2003."

San Rafael City Schools

In 2016, San Rafael City Schools signed a contract with Pacific Educational Group after "racial incidents" emerged following the 2016 election, according to a local media report.

CONNECTICUT

Greenwich Public Schools

The school district announced a <u>budget plan</u> for the 2007-2008 school year with Pacific <u>Educational Group</u> as a vendor.

New Haven Public Schools

On Nov. 10, 2020, New Haven Public Schools signed a one-year contract, effective from Dec. 1, 2020, through Dec. 31, 2020, for \$111,450, according to a copy of the Contract. It agreed to an hourly rate of \$4,650 per day to \$13,900 per day. The funding source was the "Equity Transformation Grant #4448," paid by the "Higher Heights Program" of the New Haven Board of Education.

The contract claimed an alternative contractor would cost \$115,000. To the question of whether this was a "service existing staff could provide," the contract only said: "The Pacific Educational Group (PEG) services will provide the opportunity to advance the large scale [sic] development for staff and will accelerate the district's capacity to engage in equity transformation." To another question of whether the service could be provided by "existing staff," if it was provided for professional development, the answer was just as opaque: Pacific Educational Group "will expand the districts [sic] capacity to sustain and maintain the equity transformation and development plan."

Broward County Public Schools

On Feb. 2, 2021, Public Consulting Group Manager Sophia Thwaites co-facilitated <u>a</u> webinar, "Conversations with District Leaders: Building and Sustaining Racial Equity," with Luis Versalles, Director of Pre K-12 District Partnerships at Courageous Conversation.

District 65

For vendors contracted between April 30, 2019, and June 20, 2019, the school district published a payment amount of \$38,018 for Pacific Educational Group.

Hillsborough County Public Schools

The school district <u>published details of its</u> Contract for \$1,476,292.

In a memo to the school board, the super-intendent, Jeff Eakins, wrote: "Consultants from PEG will work with Superintendent Staff, district leaders, and school based leaders to develop the districts capacity to engage in systemic equity transformation and eliminate racial and other educational disparities in Hillsborough County Public Schools. The contract will include meetings, trainings, coaching, and support with district leadership focused on the topics of diversity and equity. All district and school leaders will receive a two-day Beyond Diversity Training, which will bring awareness to the role

of equity and closing achievement gaps. A district team will be trained to continue the conversations, training, and support with all other stakeholder groups."

Speaking in St. Petersburg, Florida, Feb. 21, 2019.

GEORGIA

Bibb County

In 2012, The Telegraph reported, "In his Macon Miracle school improvement plan, Superintendent Romain Dallemand said he wants to hire the Pacific Educational Group to close the achievement gap between white and Asian students and those of color, primarily blacks and Latinos."

ILLINOIS

Chicago Public Schools

The <u>Chicago City Wire reported</u> that Chicago Public Schools renewed a contract worth \$250,000 for the services of consultant Glenn Singleton.

Evanston/Skokie School District 65

In late March 2021, the board of education issued a <u>"Land Acknowledgement."</u>

It <u>organized "Beyond Diversity,"</u> a two-day seminar, "facilitated by affiliates of the Pacific Educational Group." The local media <u>reported the board heard</u> an "earful."

New Trier

The school district <u>published a Contract</u> with Pacific Educational Group on its website.

Local media <u>reported about a Contract</u> for \$90,000 "to instruct teachers on whiteness."

Oak Park and River Forest High School District 200

On Sept. 16, 2014, the school district signed a contract with Pacific Educational Group to do "Beyond Diversity" professional development work with faculty and staff with Pacific Educational Group and seminars with Luis Versalles, costing \$17,400 for "District Executive Equity Leadership Team," or "DELT."

The school district published the details on its website.

The details from 2011-2012 were also published online.

KANSAS

Lawrence Public Schools

Since 2005, <u>Lawrence Public Schools</u> has contracted with Pacific Educational Group,

including reference to "PEG's Systemic Equity/Anti-Racism Transformation Process" and "Beyond Diversity" plan.

According to a 2015 local media report, Lawrence Public Schools spent \$362,750 for Pacific Educational Group's services between 2010 and 2015.

Topeka Public Schools

On its website, Topeka Public Schools said it is "engaging in a multi-layered racial equity development work with Pacific Educational Group to create the educational climate and culture for systemic equity transformation." It said; "This transformation includes all levels of the organization School Board: Superintendent's Council, district and site leadership and certified and classified staff. Again, the district is committed to eliminating racial disparities and predictability in academic achievement."

The school website has the analysis on its plan.

MARYLAND

Baltimore County Public Schools

According to a 2015 media report, Baltimore County Public Schools spent \$427,000 between 2010 and 2015 on the Pacific Educational Group.

According to a board Contract document, Baltimore County Public Schools agreed in June 2015 to extend for one year an earlier \$415,600 contract with Pacific Educational Group for an additional \$182,300, bringing the estimated total contract spending authority to \$597,900. The document said the changes would "accommodate training for additional participants and extend the training program for one year." It said, "The increased cost is requested for continued support of senior staff as well as training support for school-based staff, members of curriculum and instruction, business services, and communications. These services will allow the system to institute and maintain BCPS' own diversity and equity training over the coming years."

The contract was intended "provide coaching and consulting, as well as tools and protocols essential in advancing the system's ability to provide services and support to its diverse student population." It noted, "An evaluation of this year's efforts will include a mixed method reporting of the impact of training on individual, professional, and organizational capacity. Evaluation results will be available through the Department of Research, Accountability, and Assessment at the conclusion of the 2015–2016 academic year."

Its staff <u>attended the annual summit</u> in October 2019.

Talbot County Public Schools, Maryland

According to a 2015 media report, Talbot County Public Schools spent \$259,100 for Pacific Educational Group's services between 2010 and 2015.

MINNESOTA

Edina Public School District

A high-school teacher in the Edina school district crafted the curriculum of a tenth-grade English class to address "race, racism, and Whiteness." The class relied heavily on critical race theory and was designed to help students "discuss how Whiteness [is] showing up in the classrooms and hallways." According to the teacher, "[u]nderstanding [CRT] was a significant reason behind our school taking [this] step on our equity journey," and teachers "encouraged students to examine ... the ways Whiteness silences some voices and amplifies others."

Osseo Area Schools

Osseo, Minnesota, school district paid Pacific Educational Group \$533,800 over three years, according to the school district. It paid \$100,000 payment for the 2012-13 school year; \$225,000 in 2013-14; and \$208,800 in 2014-15.

In 2017, the Osseo Area School Board <u>said</u>, according to an article, it would cut funding

for diversity and equity training by Pacific Educational Group and Courageous Conversations, allocated in the "Achievement and Integration" funds in the Minnesota budget, providing training sessions called "Beyond Diversity" and "Beyond Diversity II," with required attendance by district staff leaders. Training participants also read "Courageous Conversations About Race: A Field Guide for Achieving Equity in Schools," by Glenn Singleton and Curtis Linton.

The proposed budget was for \$85,750 for consulting and license fees and \$38,100 for staff members to attend Pacific national and regional summit meetings. School board member Robert Gerhart "said the board has received phone calls and emails both in support and opposition of Pacific's programing." "He said as an elected official, he didn't feel comfortable supporting such a polarizing program. Pacific's consulting work has resulted in problems in other school districts, he said," the article said. "This is not the stuff we should be putting into our racial equity work," Gerhart said. The article said; "The programs provided by Pacific do not serve the entire population, and can reinforce stereotypes, he said." "I think you're actually establishing stereotypes where none may have existed before," he said. Another board member, Jessica Craig, said there wasn't evidence the training closed the racial achievement gap.

According to the Minneapolis Star-Tribune, the contract was for \$152,000 for the 2016-2017 year.

St. Paul Public Schools

The <u>Twin Cities Pioneer Press reported</u>, "St. Paul's minority students were often performing worse academically and had higher discipline rates than their white peers. To help address those gaps, the district hired the Pacific Educational Group, or PEG, in 2010 as its racial equity consultant. Over the next five years, nearly every district employee would receive PEG's "Beyond Diversity" training."

"Besides St. Paul, the company has worked with other Minnesota districts, including Minneapolis, Edina, South Washington County and Rosemount-Apple Valley-Eagan."

"PEG and the St. Paul district began working together in 2010. The first PEG contract was for \$3,505 to provide a "Beyond Diversity" presentation, district records show."

"In all, the district has paid the company nearly \$1.8 million for staff training and seminars. Nearly every district employee has taken part."

"The district's contracts with PEG have been on the decline since 2013, in part because St. Paul uses a "train-the-trainer" system that allows staff to train co-workers."

The <u>state also documented</u> records.

NEW JERSEY

Tredyffrin / Easttown School District

According to the <u>Tredyffrin / Easttown</u> <u>School District</u>, the school district "began a partnership" with the Pacific Educational Group in the spring of 2018, "specifically to enhance the polices [sic] and practices around racial equity." Tredyffrin/Easttown School District's director of curriculum, instruction and staff development, Wendy Towle, said it wouldn't release material from Pacific Educational Group because of "copyright concerns," according to an email obtained by <u>Parents Defending Education</u>.

The material "constitutes proprietary information" and Towle said she could not share the curriculum "without legally exposing the District to copyright violations." In a late June school board meeting, a local parent, Deana Wang, said, "America is great because of two reasons. This country nurtures innovative minds that drive progress on a global scale, and American people who seek to embrace constructive criticism." She continued: "Critical race theory is creating the indoctrination environment that will constrain children's creative sense of self and consequently limit their analytical productivity as adults."

In mid-June 2021, about 100 people filled the Conestoga High School auditorium for its first in-person meeting in over a year,

according to a WHYY report.

The Board of School Directors approved an agreement between Pacific Educational Group, Inc. and the Tredyffrin/Easttown School District to provide professional development services, effective March 1, 2019 – May 30, 2019 in the amount of \$12,000.

OREGON

Tigard-Tualatin School District 23J

Located in a southwest suburb of Portland, the Tigard-Tualatin School District 23J hired Pacific Educational Group, according to school district documents.

TEXAS

Fort Worth Independent School District

The school district published an <u>"Overview of Services Provided by the Division of Equity & Excellence."</u>

It wrote: "February 2016- Superintendent Scribner presented a new organizational structure that introduced the Division of Equity & Excellence. The charge was to implement a district-wide equity transformation plan. To accomplish this, they recognized the need for a partner with experience to assist in preparing for this journey, or this endeavor could have

negative consequences. After vetting multiple vendors, FWISD entered into a 5-Year agreement with Pacific Educational Group (PEG). PEG's format that trains our leadership and staff to reflect on their own racial experiences allows for their racial awakening to be scaffolded in order to address systemic barriers within the District. The CCAR tools help facilitate a more productive way to engage, sustain, and deepen conversations about race."

It wrote: "February 2017- After vetting the Racial Equity Policy through many entities and legal guidance, the FWISD Board approved Racial Equity Policy AE(LOCAL), and a Five-year plan (\$1.3 million) to contract with Pacific Educational Group (PEG). PEG has over 20 years of experience in supporting large organizations in cultivating a racially conscious environment."

Feb. 14, 2017, a board meeting was set with the topic, "Approve District-Wide Racial Equity Training and Program Services" and included the five-year contract with Pacific Educational Group. The funding source was the "Special Revenue General Fund" for the forest year.

In December 2019, Christie Nold wrote about her school in South Burlington, Vermont, on the website, Teaching While White.org, signing a "district partnership" with Pacific Educational Group after a "number of us on the faculty" attended the Courageous Conversation Against Racism Summit in 2017.

WASHINGTON

Lee's Summit Schools

In 2018, the local community had a debate over a contract with Pacific Educational Group, with some community members feeling it was a waste of money, according to the Kansas City media.

A local parent called then-Superintendent Dennis Carpenter, the district's first African American superintendent, the "race doctor," with his Twitter handle @EquitySupt1. He later started a diversity consulting firm, Aspirational Insights.

WASHINGTON, D.C.

District of Columbia Public Schools

The <u>equity plan</u> included Courageous Conversations.

WISCONSIN

Milwaukee Public Schools

In February 2021, Milwaukee Public Schools signed an <u>"Award of Exception-to-Bid"</u> Contract with Pacific Educational Group Inc. for professional development training

for 10 staff members to become "licensed facilitators" of "Courageous Conversations." It included \$158,1000 for 17 "Virtual Courageous Conversations Explorations" for 80 participants maximum at \$9,300 per event. And it included 10 staff engaged in "Practitioner Certification" at \$4,000 per person.

The school district <u>included documentation</u> on its website.

Sun Prairie Area School District

In 2015-2016, the school district began with the National Equity Project. It then signed a contract with Pacific Educational Group. According to a school district investigation, on Feb. 1, 2021, a lesson was created with "slaves."

What is Newsela Inc.?

Founded in 2013, Newsela, Inc., is a company that provides online news content to K-12 schools. While news content can seem neutral, it often times isn't any longer, and companies like Newsela are used to promote news with an activist and social justice perspective, as Newsela tends to do.

With 37 million registered students and 2.5 million registered teachers in 90% of all U.S. schools, Newsela is well on its way toward making legacy materials like textbooks and the long-term lock-in commitments they represent, a relic of the past.

Newsela, Feb. 25, 2021

In its promotional material, the company says, "Newsela was founded on the belief that classroom learning can be massively more engaging, effective and meaningful for all students. Launched in 2013 at the dawn of accelerating technology investments in high-speed internet and laptops, Newsela quickly became the SaaS platform of choice as the structural shift from paper-based materials to digitally delivered content unfolded in schools across the country."

On Feb. 25, 2021, Newsela announced that the company had it had raised \$100 million in Series D investment by new investor Franklin Templeton and many of the same venture capitalists that have invested in for-profit company Panorama Education Inc. They include Facebook founder Mark Zuckerberg and his physician-wife Priscilla Chan, as well as Owl Ventures.

The company noted the explosive growth in Big Tech in K-12 education.

Leading K-12 instructional content platform Newsela announced today a \$100M Series D investment led by new investor Franklin Templeton and existing investor TCV, with participation by Owl Ventures, Tao Capital Partners, Chan Zuckerberg Initiative, and Waycross Ventures.

Private U.S. edtech companies raised a record-setting \$2.2B in 2020 across K-12, higher ed, and workforce education. That's a 30% increase over 2019, and more than double the 14% YoY increase enjoyed by all venture-backed U.S. companies. Newsela's latest fundraise is a validation of the disruption taking place in the \$10B U.S. K-12 instructional materials market, and a strong acknowledgment of much-needed investment in our K-12 education system as a whole.

As of late February 2021, Newsela said it had 37 million registered students and 2.5 million registered teachers in 90 percent of U.S. schools. Newsela said it was "well on its way toward making legacy materials like text-books and the long-term lock-in commitments they represent, a relic of the past."

What services does Newsela Inc. provide?

Newsela aggregates and curates the news, and school districts subscribe to its platform as a news delivery vehicle to students. The bias and point of view of its media articles can strong influence debates, discussions and opinions in classrooms.

Orange County Public Schools

On July 30, 2019, Orange County Public Schools signed a \$700,000 agreement with Newsela Inc., vendor No. 140045, for a Newsela online subscription with a contract period from Sept. 14, 2019, through Sept. 13, 2020, with three additional one-year renewable options.

The unit and funding source was listed as "Curriculum, Instruction, & Digital Learning and General Funds."

On Sept. 9, 2021, the school district's website said that the contract's current expiration date was Sept. 13, 2022. The contract was in the Division of Teaching and Learning and the Department of Curriculum and Instruction.

What is Akoben LLC?

In 2010, <u>Abdul-Malik Muhammad</u> registered Akoben LLC, based in Wilmington, Delaware, with the Delaware Secretary of State.

Muhammad is the chief executive officer. He also founded <u>Transforming Lives LLC.</u>

What services does Akoben LLC offer?

Akoben offers a variety of workshops, consulting and coaching services, and speaking engagements to their clients. The workshops are meant to "stretch thinking, provoke reflection, and stimulate action." Principles of these workshops include "restorative practices, trauma-informed care, cultural relevancy, and agency and assets."

Parents have criticized the workshops and teachings for politicizing education, fomenting students to become activists and "disruptors."

What K-12 work has Akoben LLC done?

Palm Springs Unified School District, California

PURCHASE ORDER

Palm Springs Unified School District paid Akoben LLC \$7,250 to do consulting work during the 2020-2021 school year at four "district sites."

There was an appearance, according to a tweet.

- "Champions coaching" on Sept. 30, 2019, and Oct. 1, 2019.

➤ 25 copies of Muhammad's book, "The Restorative Journey — Book One: The Theory and Application of Restorative Practices."

The contract added: "We will use the SOAP model, Work-Study Circle process and in-vivo application to connect and challenge staff to improve along their restorative journey." "SOAP" stands for "Subjective, Objective, Assessment and Plan." "Study Circles" are a buzzword in "diversity, equity and inclusion" work, such as in Montgomery County, Maryland.

Who is Gholnecsar Muhammad?

Gholnecsar Muhammad describes herself on her Twitter account as a "Disruptor of Oppression."

An associate professor of language and literacy at Georgia State University, Muhammad, known as "Gholdy," received her Ph.D. in literacy, language and culture at the University of Illinois at Chicago. She is director of the Urban Literacy Collaborative and Clinic at Georgia State University.

The U.S. Department of Education awarded her \$750,000 to study "culturally and historically responsive literacy in STEM classrooms."

On Jan. 31, 2018, Muhammad established HILL Pedagogies LLC, based in Douglasville, Georgia, according to Georgia Secretary of State records. It is an "educational consulting company that works to advance and respond to students' Histories, Identities, Literacies and Liberation," according to its website.

On Nov. 13, 2020, she founded Hill Pedagogies Services Inc., also based in Douglasville, Georgia, according to Georgia Secretary of State records.

As of Oct. 10, 2021, her website said Muhammad "leads efforts and provides consultation

based on culturally and historically responsive education."

It continued: "We offer professional learning that shapes theory, policy and practice for educating youth who have been underserved in and around schools. Following content within the best-selling book, *Cultivating Genius*, we work with parents, leaders, teachers and young people across the United States and abroad toward best pedagogical practices."

Muhammad described herself as a "leader who strives to shape the national conversation for educating youth that have been underserved." Her biography notes that she has worked as a school district curriculum director, leading K-12 literacy instruction, assessments and professional development, a reading, language arts and social studies middle school teacher and "school board president."

On Jan. 1, 2020, she authored, "Cultivating Genius: An Equity Model for Culturally and Historically Responsive Literacyl"

In an <u>article</u> coauthored by Muhammad, headlined "Teaching Toward Genius: And Equity Model for Pedagogy in Action," she wrote, "criticality" is "the capacity and ability to read, write, think, and speak in ways to understand power and equity in order to understand and promote anti-oppression."

She continued: "In Cultivating Genius, I (Gholdy) define oppression simply as any wrongdoing, hurt, or harm, including racism, sexism, homophobia, ableism, or any other oppression. Unlike lower case "c" critical, which is just deep and analytical thinking, Critical with a capital 'c' is related to power, equity, and anti-oppression. As learning takes place, one asks, 'How am I developing an understanding of power, equity, anti-racism and anti-oppression?"

On June 23, 2020, Haymarket Books <u>hosted</u> a <u>conversation</u> with Muhammad, Bettina Love, founder of Love Educational Services, LLC, consultant Dena Simmons and Brian Jones, associate director for education at the Schomburg Center for Research in Black Culture, about "abolitionist teaching and antiracist education."

She spoke about reading the Qur'an as a child and reading a hadith, or saying or action of Muhammad, the prophet of Islam, that said to protest injustice with "the voice" as one of three actions. (The hadith is not included in Qur'an.)

Love repeated a theme of hers: "They're spirit murdering our babies." (24:00)

In mid-July 2021, Muhammad taught a course, "Cultivating Genius & Joy in Islamic Schools," hosted by Islamic Schools League of America. She is author of a book, "Cultivating Genius: An Equity Framework for Culturally and Historically Responsive Literacy."

What services does Gholnecsar Muhammad offer?

Through her company, Hill Pedagogies, Gholnecsar Muhammad offers a number of services, including: "book club/article studies," "curriculum review and evaluation," "consulting with school or district leadership," "equity audits," "grant writing or consulting," "instructional coaching," "instructional modeling," "literacy audits," "lesson study; curriculum writing," "keynotes" and workshops.

On June 23, 2020, Haymarket Books hosted a conversation with Bettina Love, founder of Love Educational Services, LLC, academic Gholdy Muhammad, consultant Dena Simmons and Brian Jones, associate

director for education at the Schomburg Center for Research in Black Culture, about the promotion of "abolitionist teaching and antiracist education" in K-12 schools.

In an interview headlined, "Cultivating Genius," on Education Week, Muhammad said: "Black Historical Excellence is necessary because what we have been doing for decades has not fully served all children, especially Black children. We have been failing children. We have been failing children. We have been teaching within school walls of whiteness."

What K-12 work has Gholnecsar Muhammad done?



In 2018, Muhammad received a grant of \$749,896 grant from the U.S. Department of Education to study "Innovative Approaches to Literacy Program, "STEM is LIT(ERCIES): A Culturally and Histori-

cally Responsive Model for Teaching Literacy Across STEM," according to an announcement by Georgia State University.

In her resume, Muhammad detailed that she received \$794,030 in "funded grants" between 2015 and 2018.

Castro Valley Unified School District

On Feb. 25, 2021, Muhammad participated in a panel, "Black Futures & Black Joy," moderated by Bettina Love, cofounder of the Abolitionist Teaching Network and founder of Love Educational Services, LLC.

The <u>registration</u> page for the event said: "Our future is BLACK and filled with JOY. This beautiful panel will take us on a journey of a Black future filled with joy, justice, art, and love."

The other speakers were Stacey Robinson, assistant professor of graphic design at the University of Illinois at Urbana- Champaign, and Yolanda Sealey-Ruiz, an associate professor at Teachers College, Columbia University.

Los Angeles Unified School District

Sealey-Ruiz!

In February 2021, the Partnership for Los Angeles Unified School District sent a letter to parents, introducing Muhammad as its "Equity Champion in Residence," supporting instructional staff and strengthening "anti-racist" work.

Muhammad promoted "Historically Responsive Learning," which included critical race theory as one of four significant elements to be included in planning lessons. She went to one school and said that that it wasn't possible for a community to be "not racist." Teachers spent up to five hours in professional development on units that teach intelligence, skills, identity, and "criticality," or "oppression, equity, and antiracism."

The school district paid Muhammad \$2,875 for a two-hour virtual workshop.

OHIO

Olentangy Local School District

On Dec. 1, 2021, Muhammad signed a contract with Olentangy Local School District to deliver a one-hour keynote address, "Cultivating Healing and Joy Through Culturally and Historically Responsive Pedagogy," for a fee of \$4,000.

The outcomes included educators getting an "understanding of culture, equity, anti-racism, joy, and culturally & historically responsive instruction," which she called "CHRE."

The contract stipulated:

▶ In the virtual, foundational session, Dr. Gholdy Muhammad will present for 30 minutes clearly defining culture, equity, anti-racism, joy, and culturally & historically responsive education. Together, culture will be explored and revisited in deep, multifaceted ways. We will consider our own cultural identities and approaches to learning the cultures/identities of students. By the end of this session, the educators will understand culture and will be charged to engage in selfidentity work. The facilitator will also introduce educators to the model of culturally and historically responsive education. Educators will learn a brief history of CHRE and the power of education among communities of color in the United States. In addition, educators will be introduced to a fourlayered equity model for teaching and learning (1) identity, (2) skills, (3) intellectualism and (4) criticality. Exemplar CHRE lesson and unit plans across the contents and grade levels will be shown and discussed. The participants will engage in 30 minutes of questions and answers.

Collaborative for Academic, Social, and Emotional Learning (CASEL)

What is the the Collaborative for Academic, Social, and Emotional Learning, or CASEL?

The Collaborative for Academic, Social, and Emotional Learning, or CASEL, describes itself as a "trusted source for knowledge about high-quality, evidence-based social and emotional learning," known as "SEL." CASEL says it "supports educators and policy leaders and enhances the experiences and outcomes for all PreK-12 students."

In its history section on its website, the organization says, "Both CASEL and the term

'social and emotional learning' emerged from a meeting in 1994 hosted by the Fetzer Institute." From 1996 through 2006, CASEL was based at the University of Illinois at Chicago.

In 2006, CASEL registered with the Secretary of State in Illinois as 501(c)(3) nonprofit organization, based in Chicago (EIN: 20-5884201).

Since its creation in 2016, the Collaborating States Initiative "has scaled state-level SEL work from 8 states to over 40 states and one

U.S. territory, representing more than 90% of districts, schools, teachers, and students in the US," according to CASEL's website.

What services does CASEL offer?

CASEL says it is engaged in four areas of services. First, it "compiles and synthesizes research that promotes SEL in addition to conducting their own original research."

Second, it "assists in implementing SEL" with 20 "partner school districts, reaching 1.7 million students in 3,000 schools and "develops resources to help guide implementation of SEL." Its consultants also "create materials to help stakeholders 'make a compelling case' for SEL in their school district based off of their research."

Thirdly, CASEL "engages in lobbying at both the state and federal level," working with a network, the "Collaborating States Initiative," with 30 "participating states."

One specific goal of the initiative is to influence the state educational strategic planning process so that "state educational goals and objectives advance" social and emotional learning. According to CASEL, 50 states currently have preschool competencies and standards in social and emotional learning,

and 18 states have K-12 competencies and standards. At the federal level, CASEL says its focus is working to increase funding for social and emotional learning research.

CASEL assists in implementing social and emotional learning within school districts in a variety of ways. The organization has consultants that run trainings and promote social and emotional learning within the school district, offering "evidence" to support implementation, and determining the "cost model" of implementation.

It offers to "build foundational support" for social and emotional learning and pitch administration on social and emotional learning, as well as guides for implementation.

There are four case studies of its work found at this link with

Austin Independent School District, Chicago Public Schools, Washoe County School District and Wheaton-Warrenville Community School District.

The organization states that about half of its program revenue comes from CASEL consultant trainings. The other half comes from its major annual event, "SEL Exchange," held every October and attended by K-12 staff and administrators. It gets sponsorships for the event.

CASEL has consultants that offer "technical support" and training to K-12 schools. From the case studies on the organization's website it seems that the consultants are typically involved on an ongoing basis after the SEL is implemented.

The 20 school districts that are a part of CASEL's Collaborating Districts Initiative

typically get a \$250,000 grant over three years from NoVo Foundation, along with two CASEL consultants.

CASEL consultants also provide "professional development and coaching to the districts that are part of... [the] SEL professional learning community (PLC)."

CASEL consultants facilitate training for partner school districts. For example, they hosted one-day and two-day SEL retreats they hosted for the Washoe Community School District Curriculum and Instruction Department of the Washoe County School District.

What K-12 work has CASEL done?

- ▶ In 2020, the chief executive officer, Karen Niemi, wrote an article, "CASEL Is Updating the Most Widely Recognized Definition of Social-Emotional Learning."

CASEL has been involved in Anchorage School District for "three decades," according to CASEL.

In an agreement revised on Feb. 3, 2016, Anchorage School District agreed to pay CASEL **\$25,000** for services from April 1, 2016, through April 1, 2017, developing a "system that combines SEL, AK Cultural Standards and the Danielson Framework that will maximize educator effectiveness to meet the social and emotional needs of a diverse student population," according to page nine of the agreement.

SERVICE AGREEMENT

On May 3, 2016, Anchorage School District's executive director of professional learning signed an agreement with CASEL to pay the government contractor \$13,000 for an "analysis of the districts' SEL-related data," in order to "determine the impact of SEL implementation activities and form future plans for SEL data collection, use and continuous improvement," according to Appendix A on page nine of the agreement.

The services would be provided April 1, 2016, through June 30, 2016.

The contracts included: one site visit from CASEL's director of assessment and continuous improvement, meeting with school and

district leadership teams and community organizations; one site visit from a CASEL research associate; one one-hour collaboration calls [sic] monthly with two CASEL staff members, with three calls over a year's time, "added-on to scheduled calls"; and three days of data analysis by CASEL's director of assessment and continuous improvement.

It said, "The collaboration will produce analysis findings that can be presented to district leadership, the school board, the community, and any other key stakeholder."

Anchorage School District has an official website page <u>dedicated to "Social and Emotional Learning."</u>

Oakland Unified School District

Oakland Unified School District has an <u>official page on its website dedicated</u> to its "social and emotional learning." The school district began working with CASEL in 2012.

The school district website notes: "In 2011, CASEL launched a national initiative called the Collaborating Districts Initiative, aimed at supporting districts' capacities to promote SEL for all students. One year later, OUSD joined the CDI to work with and learn from the other 7 participating school districts.

The CDI recognizes that positive student outcomes depend on improving classrooms and schools, which in turn depends on improving districtwide capacities and conditions. For more information on CASEL's Collaborating Districts Initiative, click here."

As of Oct. 12, 2021, CASEL listed the school district on its website, identifying districts participating in its Collaborating Districts Initiative. (see above)

Sacramento City Unified School District

As part of the "Scope of Services," in Attachment A, CASEL agreed to "provide support, training, and guidance in developing and executing a plan for systemic implementation of social and emotional learning (SEL)."

As of mid-October 2021, The School District of Palm Beach County promotes "social and emotional learning" on its website with a list of "CASEL Core Competencies." CASEL also listed the school district on its website, identifying districts participating in its Collaborating Districts Initiative. (see above)

CASEL is involved with the school district through a partnership with the Wallace Foundation.

CONSULTANT AGREEMENT

On Sept. 12, 2018, The School District of Palm Beach County signed a consulting agreement with CASEL to pay the contractor \$150,000 for the same services as the year before. What is Mid-Atlantic Equity Consortium, Inc.?

Based in Bethesda, Maryland, a suburb of Washington, D.C., Mid-Atlantic Equity Consortium, Inc. was founded in 1992, as an education non-profit dedicated to "increasing access to a high quality education for culturally, linguistically, and economically diverse learners." The organization states that its mission is to "promote excellence and equity in education to achieve social justice."

As of Sept. 9, 2021, the U.S. Department of Education listed the Mid-Atlantic Equity

Consortium as the organization managing one of its "regional technical assistance centers" through ae Mid-Atlantic Equity Consortium project, the "Center for Education Equity."

According to its 2019 990 IRS filing, it had \$2.17 million in total revenue, up slightly from \$2.12 million the year before.

The Free Beacon reported that, of the \$19 million the group has raised since 2001,

\$17 million is from "taxpayer-backed cash," according to a review of its financial filings. Its most recent tax forms showed that from mid-2018 to mid-2019, the group spent \$1.6 million on "equity projects" to examine and address systematic policies and practices, about \$233,000 on "family engagement" projects to build partnerships among schools and parents, and about \$74,000 on youth projects. Susan Shaffer, the group's president, received more than \$200,000 in salary, and Maria Del Rosario Basterra, a vice president, was paid more than \$140,000.

In May 2007, the organization said it hired Shaffer Law Firm PLLC, where now-president Susan Shaffer's husband is a partner. In its 2018 990 filing, the organization said it paid the Shaffer Law Firm PLLC \$36,000 for "ongoing legal services," noting that president Susan Shaffer's husband worked there.

Their areas of focus include race, gender, religion, national origin (described as "English learners"), multicultural and compliance. Their areas of need include educational equity, English learners, family, school and community engagement, school climate and culture and school transformation.

What is Nicole Anderson and Associates Consulting LLC?

For four years, Nicole Anderson, a former elementary school teacher in Vallejo, Ca., zipped around the state of California as a trainer for the Association of California School Administrators.

In February 2020, Anderson <u>registered</u> Nicole Anderson and Associates Consulting LLC as a <u>limited liability company</u> with the California Secretary of State, listing herself as the chief executive officer, based in Vallejo.

In 2018, she opened her own shop, Nicole Anderson and Associates Consulting, L.L.C. to "deliver a unique systemic approach to providing professional development services" to educators. Today, she sells her services across the state. Her LinkedIn profile says she is also a consultant with Epoch Education Inc., McPherson and Jacobson L.L.C., an executive recruitment firm, and a consultant for the California School Boards Association.

In her online resume, she says she is also a business owner with Bethel Educational Solutions and Equity Now and Associates, and she is also a consultant with Generation Ready and Footsteps to Brilliance.

In her resume, she says she works with national organizations and partners to "develop equity leadership programs and services," including the National Alliance of Black School Educators, NASS (the national superintendent's association), Generation Ready and Community Responsive Education.

Calling herself an "Educational and Racial Equity Consultant," she says on her website that her company is "successfully serving school sites, districts, county offices, school boards, superintendent search firms, and associations in addition to multiple sectors across the nation."

For example, the Winters Express reported that on Tuesday, June 3, 2021, the Board of Trustees of the Winters Joint Unified School District in Winters, Ca., approved using funds from the Coronavirus Aid, Relief, and Economic Security Act, or CARES ACT, passed in March 2020 for a one-year, \$34,000 contract for the 2021-22 school year for "interactive equity training workshops."

The Winters Express reported: "The contract proposal submitted by Nicole Anderson and Associates Consulting (NAAC), stated, 'In order to close racial equity gaps seen in schools, it is essential that educational leaders build capacity and shift the paradigm of a school system that was not designed to yield successful outcomes for all students."

The contract reportedly includes six in-person training days between July 29, 2021, and April 28, 2022.

Board President Carrie Green released a statement about the contract, stating, "When I came on the board almost seven years ago our student data hasn't changed much. Our percentages have remained consistent – about 30 – 40 percent of our students being at or slightly above grade level proficient in reading and math. And that's district wide," Green said. "I think that we can all agree that as a community having 60 – 70 percent of our kids being one or more grade levels behind is not OK."

Trustee Joedy Michael told the board he was excited to do this, "especially coming off some of the testing data suggests that we have some gaps that we need to evaluate."

The Board approved the one-year contract with a 4-0-1 vote (Trustee Candi Ochoa was absent).

What K-12 work has Nicole Anderson and Associates Consulting LLC done?

On its website and publicity material and Anderson's professional resume, Nicole Anderson and Associates Consulting promotes dozens of school districts where it says it has done work. Several school districts said they did not have documentation of contracts with the company in response to public records requests. Parents Defending Education is contacting Nicole Anderson and Associates Consulting and the school districts for clarification.

On Nov. 27, 2002, Michael Moody registered Insight Education Group Inc., based in Encino, California, as a corporation with the California Secretary of State. The firm claims to impact of 250,000 educators and four million students in more than 20 states and the District of Columbia.

Its "core values" include "equity as the driving force behind all of our decisions, including:

"hiring diverse professionals, empowering teachers and school leaders, creating tools and culturally responsive resources, and participating in and facilitating conversations around bias, prejudice, and race." The company notes: "We will forever be champions of equity."

The chief executive officer and cofounder is Jason Stricker.

What services does Insight Education Group Inc. offer?

The company says its leaders <u>believe</u> that "education empowers individuals to disrupt the impact of systemic racism," hire "diverse, race-conscious educators who engage in

intentional, ongoing development of self, rooted in the tenets of anti-racism," and work to "strategically dismantle practices that perpetuate structural racism."

What K-12 work has the Insight Education Group Inc. done?

Insight Education Group says on its website that it had 14 projects funded by the Teacher and School Leader Incentive Program Grant from the U.S. Department of Education in 2017, Empowering Educators to Excel, or "E3." It calls the work an "exciting partnership bringing much-needed support and growth opportunities for teachers and school leaders in 47 relatively small and/or rural schools in Delaware, Indiana, South Carolina, and Texas by creating a networked improvement community."
