Equity Gap in School Discipline

Research Brief



Black, Hispanic, and Native American students are **two to five times as likely** as White and Asian students to be suspended or expelled.


Exclusionary discipline practices (practices that take students out of the classroom and away from learning, including office referrals, suspensions, and expulsions):

- reduce students' institutional trust and academic achievement;
- increase students' academic disengagement and rule-breaking;
- increase students' risk of dropping out;
- predominantly push students of color into the school-to-prison pipeline.

School Discipline and Juvenile Justice Involvement

Research Brief



"When a student was suspended or expelled, his or her likelihood of being involved in the juvenile justice system the subsequent year increased significantly."

- More than one in seven students was in contact with the juvenile justice system (i.e., contact with a county's juvenile probation department) at least once between seventh and twelfth grade.
- Nearly half of those students who were disciplined 11 or more times were in contact with the juvenile justice system. In contrast, 2 percent of the students who had no school disciplinary actions were in contact with the juvenile justice system.
- When controlling for campus and individual student characteristics, the data revealed that a student who was suspended or expelled for a discretionary violation was nearly three times as likely to be in contact with the juvenile justice system the following year.

Legal Review

Summary of Key Changes

- KLGB Law Enforcement Involvement in Student Matters
 - New policy to clarify overarching guidance for staff
 - Informed by Drummond model policy KLG and ACLU of Washington State model policy.
 - Clarifies that school discipline is the responsibility of school staff and that law enforcement shall not be involved in student discipline
 - Articulates guidance for requesting law enforcement assistance depending on the level of threat to safety and the seriousness of the incident
 - Provides expectations for responding to visits by law enforcement limiting the circumstances when a student could be interviewed and the support for them



Summary of Key Changes (cont.)



- JRA Student Records and Information
 - Eliminate reference to designated law enforcement unit
 - Updates language for gender neutral pronouns
- JRA R Student Records and Information Admin Guidelines
 - Eliminate reference to designated law enforcement unit
 - Updates language for gender neutral pronouns
- KI Visitors
 - Remove references to visits by law enforcement and DHHS
 - Add language for disruptive visitors
 - Remove legal references

 - Update language for clarity
