Good Evening. Thank you for taking my phone call this evening.

It has come to my attention, that a parent advocacy group has made a complaint with the District in regards to posters in your classroom that promote political and social viewpoints that may distract from the learning. Since the complaint, additional parent calls have been received, and at least one posting has appeared on Twitter. The posters in your classroom are now causing a school disruption. By 8:00 am on Friday, September 17, 2021, you are directed to remove the following posters:

- F*** Amerikkka This is Native Land
- In 2020, Make Israel Palestine Again and Make Amerikkka Turtle Island Again
- Corona virus is not the crisis. Capitalism is the crisis. Settler colonialism is the crisis. Empire
 is the crisis. The disease arrived with the birth of Amerikkka, and its time we finally confront
 and heal it.
- We honor mothers who have lost children who lost children to drone strikes. Incarcerated mothers separated from their children by the carceral state. Indigenous mothers searching for missing children. Palestinian mothers with children in Israeli Jails. Mothers torn from their children at the cruel borders of empire. Non-binary mothers. Mothers who care for children not their own. Mothers who didn't know how to be mothers. The child inside of you who survived by being their own mother.

I took case to OGC and the Staff Relations Team for review this morning, and the recommendation was an issuance of an NOUA with 1-3 days of suspension based on the charges below:

CHARGES:

- 1. During the period commencing on or about August 16, 2021 and ending on or about September 17, 2021, Teacher at Hamilton High School, violated District policy when he displayed in his classroom a poster with the following content:
 - a. "Policing is a violent, anti-black, settler institution that originated as slave patrols. Their primary mandate is to project property and to militarily enforce white supremacist capitalism. They are doing their jobs as they are trained and paid to do. You can't fix what isn't broken. That's why we fight for police and prison abolition. F*** the police".
- 2. During the period commencing on or about August 16, 2021 and ending on or about September 17, 2021, violated District policy when he displayed in his classroom a poster with the following content:
 - a. "Settler Colonialism Genocide Slavery Imperialism War on Drugs Jim Crow Prison Labor F*** AMERIKKKA. THIS IS NATIVE LAND."
- 3. During the period commencing on or about August 16, 2021 and ending on or about September 17, 2021, violated District policy when he displayed in his classroom a poster with the following content:
 - a. "Corona virus is not the crisis. Capitalism is the crisis. Settler colonialism is the crisis. Empire is the crisis. The disease arrived with the birth of Amerikkka, and it's time we finally confront and heal it."
- 4. During the period commencing on or about August 16, 2021 and ending on or about September 17, 2021, violated District policy when he displayed in his classroom a poster with the following content:
 - a. "In 2020, make Israel Palestine again and make Amerikkka Turtle Island again. Free Gaza"
