Dear Roger Schulman:

Open Society Institute-Baltimore ("OSI-Baltimore"), a program of Alliance for Open Society International ("AOSI"), is pleased to award Fund for Educational Excellence (the "Grantee") a project grant in the amount of 180,000.00 USD for the period from September 1, 2021 through August 31, 2022. The purpose of the grant is to enable The Re-Engagement Center to contribute to Baltimore City's COVID vaccine equity efforts, as described in the submitted proposal (the "Project").

Upon receipt of the countersigned original of this agreement, and provided any outstanding reporting requirements resulting from this or previous OSI-Baltimore grants have been satisfied, OSI-Baltimore will pay the grant in a single installment.

The Grantee agrees to use the Grant funds solely for religious, charitable, scientific, literary or educational purposes as defined by Section 170(c)(2)(B) of the United States Internal Revenue Code of 1986, as amended (the "Code").

Accordingly, reports shall be due on or before the dates set forth below:

The reports should include narratives describing the project's progress and financial statements detailing how all grant funds were expended. All financial reports should account for cumulative expenses to date.

Requests to make substantive changes to the goals and products noted in this agreement must include a rationale for the changes and be in writing. It may be necessary to include a request to revise the

budget depending on the extent of the proposed modifications. Any increases or decreases to a budget line of more than 10% must be approved by OSI-Baltimore in advance in writing.

The Grantee agrees to acknowledge OSI-Baltimore's support in the beginning of any publication (including film and electronic publications) referring to or resulting from this grant, as follows: "Supported [in part] by a grant from the Open Society Institute-Baltimore."

The Grantee also agrees that OSI-Baltimore may include information about the Grantee and its activities in its own annual reports and may distribute such information to third parties. The Grantee agrees to maintain adequate financial records consistent with generally accepted accounting practices and to retain such records for at least five years after the conclusion of the grant period. OSI-Baltimore may monitor and conduct an evaluation of Grantee's operation under this grant, which may include visits from OSI-Baltimore staff or representatives to observe the Grantee, discuss its programs with the Grantee's personnel and review financial and other records and materials connected with the activities financed by this grant. In addition, the Grantee agrees to allow OSI-Baltimore to publish, in any printed or electronic medium, information regarding this grant.

The Grantee acknowledges and confirms that the Grantee will use the grant funds only as described in the proposal and budget and in compliance with all applicable laws. In connection with this understanding, the Grantee acknowledges and confirms that it will not use the funds provided under this agreement, directly or indirectly, in support of activities (a) prohibited by U.S. laws related to combatting terrorism or money laundering; (b) involving persons identified on the List of Specially Designated Nationals (SDN) (www.treasury.gov/sdn), or entities owned or controlled by such persons; (c) in, or involving persons or entities operating, organized, or resident in, a country or territory against which the United States maintains comprehensive sanctions (currently, Cuba, Iran, Syria, North Korea, Venezuela, and the Crimea Region of Ukraine), including by providing services or support to persons resident in such countries or territories; or (d) that would otherwise violate, or cause OSI-Baltimore to violate, economic or financial sanctions, export controls, or trade embargoes imposed by the U.S. government. Should OSI-Baltimore determine, in its sole, exclusive and confidential discretion, that the Grantee has engaged in, permitted or authorized activities in violation of this section, the Grantee shall return to OSI-Baltimore in their entirety all monies paid to the Grantee hereunder.

At the conclusion of the grant period, the Grantee agrees to return to OSI-Baltimore any portion of the grant funds not expended for the purpose of this grant. Notwithstanding the foregoing, if the portion of unexpended grant funds is no more than USD\$200, then the unexpended funds may be retained by Grantee and expended for Grantee's charitable purposes; provided that the Grantee agrees that it will not use the retained unexpended funds (i) to advance any purpose other than the one specified in section 170(c)(2)(B) of the Internal Revenue Code of 1986, as amended (the "Code"); (ii) to carry on propaganda, or otherwise attempt, to influence legislation, within the meaning of Code section 4945; or (iii) to influence the outcome of any specific public election, or carry on, directly or indirectly, any voter registration drive, within the meaning of Code section 4945(d) and except as provided in Code section 4945(f).

The Grantee (i) understands and acknowledges that OSI-Baltimore may ask the Grantee to provide signed certifications to OSI-Baltimore confirming the Grantee's compliance with this representation at any point up to five years after the Grantee receives the final payment under this agreement, and (ii) agrees to provide such certifications upon request.

OSI-Baltimore may terminate this Agreement in whole or in part if the Grantee materially fails to comply with the terms and conditions of the Grant. OSI-Baltimore reserves the right to require that the Grantee return Grant Funds disbursed to the Grantee if it determines in its sole discretion that the

Grantee has failed to use the Grant Funds for the stated purpose of the Grant or if the Grantee violates conditions of this agreement.

By your countersignature below, you agree on behalf of the Grantee to the terms of this grant and that all funds shall be properly expended for charitable purposes and in compliance with the governing principles of OSI-Baltimore. You also acknowledge that this agreement is the entire agreement between the Grantee and OSI-Baltimore concerning this grant. Any modification, waiver, or amendment of this agreement must be agreed to in writing by an authorized representative of the Grantee and an authorized representative of OSI-Baltimore. Notwithstanding the foregoing sentence, if OSI-Baltimore approves a no-cost extension request of this agreement from the Grantee, OSI-Baltimore electronic notification of such approval shall serve as an amendment of this agreement. A no-cost extension extends the grant period and/or modifies the reporting or payment schedules with no additional funding. Requests for no-cost extensions and other modifications shall be submitted through the online Foundation Connect system. The Grantee acknowledges that it is not relying on any representation of OSI-Baltimore, except as set forth in this agreement, and that no representations OSI-Baltimore may have made in the past survive.

The Open Society Foundations ("OSF") has established the position of Ombudsperson to receive complaints about abuse of authority such as rudeness, invidious favoritism or bias, dishonesty, or other misfeasance by any entity or program within OSF, including by members of Boards or staff. On behalf of the Fund for Educational Excellence (Fund), I am pleased to inform you that Baltimore City Public Schools' Department of Multiple Pathways has been awarded a grant of up to \$82,000 to support Teacher Stipends and APEX Academic Licenses for the Re-engagement Center as outlined below. This grant will have a start date of January 1, 2022 and an end date of August 31, 2022. These dollars are part of a recent Open Society Institute – Baltimore grant in support of the City Schools Re-engagement Center's educational and youth development efforts

This grant shall be used to support the following Re-engagement Center's program costs:

- Teacher stipends and related FICA costs
- APEX Academic Licenses

As part of this grant agreement, City Schools' Department of Multiple Pathways' Re-engagement Center shall be responsible for:

- Identifying, coordinating, and overseeing teachers working with the Re-engagement Center's educational efforts.
- Working closely with schools related to the purchase of APEX Academic Licenses.
- Ensuring that the City Schools' Office of Data Monitoring and Compliance has accurate, timely information on efforts related to this grant initiative including both stipends and license purchases.
- Assisting the Fund in the preparation of accurate and timely progress reports as outlined in the Open Society Institute-Baltimore grant award.

As part of this grant agreement, the Office of Data Monitoring and Compliance shall be responsible for coordinating and/or managing the following:

• Providing timely and accurate invoices for reimbursement to the Fund detailing the payroll stipends and related FICA payments for staff assigned to this grant and APEX licenses purchased by City Schools' Department of Multiple Pathways Re-engagement Center. Invoices should be forwarded to the Fund to the attention of Bud Cavanaugh, Finance and Human Resources.

As part of this agreement, the Fund will be responsible for:

- Reimbursing City Schools on a timely basis for invoiced salary and APEX license expenses for this grant up to a total of \$82,000.
- Ensuring that these grant dollars are used solely for the purpose stated in this agreement.
- Serving as fiscal agent for the remaining Open Society Institute Baltimore Re-engagement Center support grant dollars.
