**3010** - Consider IDYCA program. Enrollment is different. (Statement about IDYCA exemption from rule)

I'm not sure what changes should be made. What kind of statement should be added, and to which part of the policy?

**3050** - Reduction in values of assignments of not more than 10% (Difficult to make uniform unless we make a broad rule) (Statement on uniform reduction or none at all) I changed the wording to reflect this. Please review the attached policy and let me know if the highlighted changes will work as-is, or if changes should be made to them.

Truancy - Do we assign Friday school? (Remove Friday/Saturday School portion) I've removed all references to Friday/Saturday School. If any further or different changes should be made (besides removing the highlighting and deleted items), please let me know.

**3060:** Edits were made to this policy in the Spring 2018 Update. **Would the Board like to adopt the update as shown in the attached, or with edits?** 

**3080** - The new update (Option 1, Option 1)

I've added the updates to this policy as shown in highlighting and strikethrough, with Options 1 and 1 only. Please let me know if there are any further changes that should be made.

**3250** - Paragraph 4 - (add or designee after Superintendent approval) Done

**3260** - We do not support the Bring Your Own Technology Program (BYOT))(Do not adopt) I've removed this policy and form.

**3265A2** - (Devices allowed, With Controls) I've removed the other version.

**3270** - (Option 1 - no personal use, Option 2 - supervised personal use. Both still monitored by district) (Approve both options on page 6)
