Good morning,

Thank you for your interest in ISBA's policy services! The cost to purchase the Model Policy Manual is \$2,000, and a Fresh Start Rewrite costs \$4,000.

I thought of one other thing you should know about the rewrite process. Because special education is such a specialized are of education law, our policy services regarding it are relatively limited. We have some policies on this topic, but do not include customization of these policies in the rewrite.

As I noted when we spoke, subscription to the Policy Update Service, at a cost of \$695 per year, is required while the rewrite is underway and strongly recommended as a way to keep the policies up to date after the rewrite is complete and for districts that purchase the Model Policy Manual. ISBA has started offering a package deal that allows Districts to receive a year's subscription to the update service for free with State-reimbursable Board professional development.
