Dear Robert,

After the first full week of the legislative session, we have news of a fast moving bill that would suspend the school district budget approval language in 16 VSA Section 563(11)(D). Please read below for more information about the bill and how it could affect upcoming budget ballot language.

## HOT TOPICS

### Fast Track Bill Suspending School District Budget Approval Language Passes the House

[H.42](#), which includes a provision that would suspend the requirement for the mandatory, specified school district budget ballot language in [16 VSA Section 563\(11\)\(D\)](#), passed the House today.

H.42 also provides temporary authority until July 1, 2024 that: (1) permits a municipal legislative body to move the date of the annual municipal meeting, apply the Australian ballot system to annual and special meetings, and hold electronic informational meetings in the days preceding the annual meeting; and (2) permits a public body to hold electronic meetings without designating a physical location and without requiring staff to be physically present at that location.

Although nothing is certain in the legislative process, it is very likely that the bill will be approved by the Legislature and become effective upon passage. VSBA will inform you promptly if the bill becomes law.

We're excited to announce that the McClure Foundation has awarded the VSBA a grant to support the formation of school board affinity group(s).

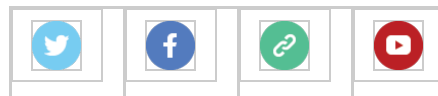
