### Harwood Unified Union School District Wins NSBA Silver Magna Award

The NSBA announced the winners of its Magna Awards today and a Vermont district is among them. Harwood Unified Union School District earned a silver Magna Award for its Harwood Harkness Initiative (HHI).

Harwood established the HHI in 2016 with a \$100,000 grant award from the Rowland Foundation. The program, led by history teacher Katherine Cadwell and a cadre of dedicated high school faculty and students, aims to transform teaching and learning by infusing the Harkness pedagogy of student-driven inquiry into classroom culture and practice. HHI amplifies student voice, encourages a diversity of perspectives, equity and inclusion in classroom culture and develops the skills of civil discourse throughout the school.

The School Board of the Harwood Unified Union School District has played an important role in supporting the work of the educators, both financially and instructionally, throughout the development and implementation of this unique approach to teaching and learning. Since individual voice and the democratic tradition of a New England Town Hall is central to our way of life in Vermont, the School Board sees the use of HHI as an important way to both educate and encourage students to take initiative in their learning, find their own voice, and engage with others knowing that respectful disagreement is critical to life in a free society.

NSBA's Magna Awards program has a long history of recognizing exemplary school district programs. The 2023 awards program focused on innovation in education. It honors district programs that solved a challenge with creativity and out-of-the-box strategies. All of the Magna Award winning districts will be featured in the April issue of American School Board Journal and recognized at an annual conference reception in Orlando, Florida.

## Act 1: Temporary Measures Related to Annual Meeting and Open Meeting Law Are in Effect Until July 1, 2024

[Act 1 of 2023](#) took effect last week. Act 1 provides temporary authority until July 1, 2024 that: (1) permits school boards to move the date of the annual meeting, apply the Australian ballot system to annual and special meetings, and hold electronic informational meetings in the days preceding the annual meeting; and (2) permits public bodies to hold electronic meetings without designating a physical location and without requiring staff to be physically present at that location.

Act 1 also suspends the mandatory, specified school district budget ballot language in 16 VSA Section 563(11)(D). Please direct questions on how to manage the wording of budget ballot language to your respective school district legal counsel.

## Applications For Act 11 Bargaining Commission Due February 1

State law requires the Vermont School Boards Association to appoint representatives to the Statewide Bargaining Commission on School Employee Health Benefits (five commissioners and two alternate commissioners). VSBA is currently accepting applications to fill two vacancies in alternate commissioner seats. The term for the alternate seats is the remainder of the two alternate members' terms (4 years).

Applicants must meet the following statutory criteria:

- an understanding of health care,
- an understanding of employer-employee relations, and
- a demonstrated willingness to work collaboratively.

VSBA Resolution IV., H requires the VSBA to give priority to applicants who provide regional representation, have experience on a negotiations council, and demonstrate willingness to participate in training and professional

development regarding negotiations.

The VSBA Board of Directors will appoint the alternate representatives to the Commission based on the above criteria. Applicants may be interviewed by the Board at its February 8, 2023 board meeting from 5:00-8:00pm.
