## **GOVERNANCE TIPS**

## Clear, Shared, and Community-informed Governance Priorities

School Boards wanting to focus on effective governance will pay special attention to their priorities, protocols, and processes. If the board has not written down their priorities for the year and clearly communicated them to the superintendent and community, how can the superintendent be held accountable for making progress on the board's desires? Research shows a correlation between

- 1. boards having clearly defined goals for the district and superintendent,
- 2. communicating those goals to the community, and
- 3. using them as the basis for superintendent evaluation with the likelihood that student outcomes are improving in a school district.

There is also evidence to support that the more a board involves their community–including staff, families, students, and every constituent group–in establishing a vision and goals, the more likely the district is improving in student learning overall while at the same time closing gaps. Clear and shared (by all board members) governance priorities are the cornerstone for

effective governance.
