

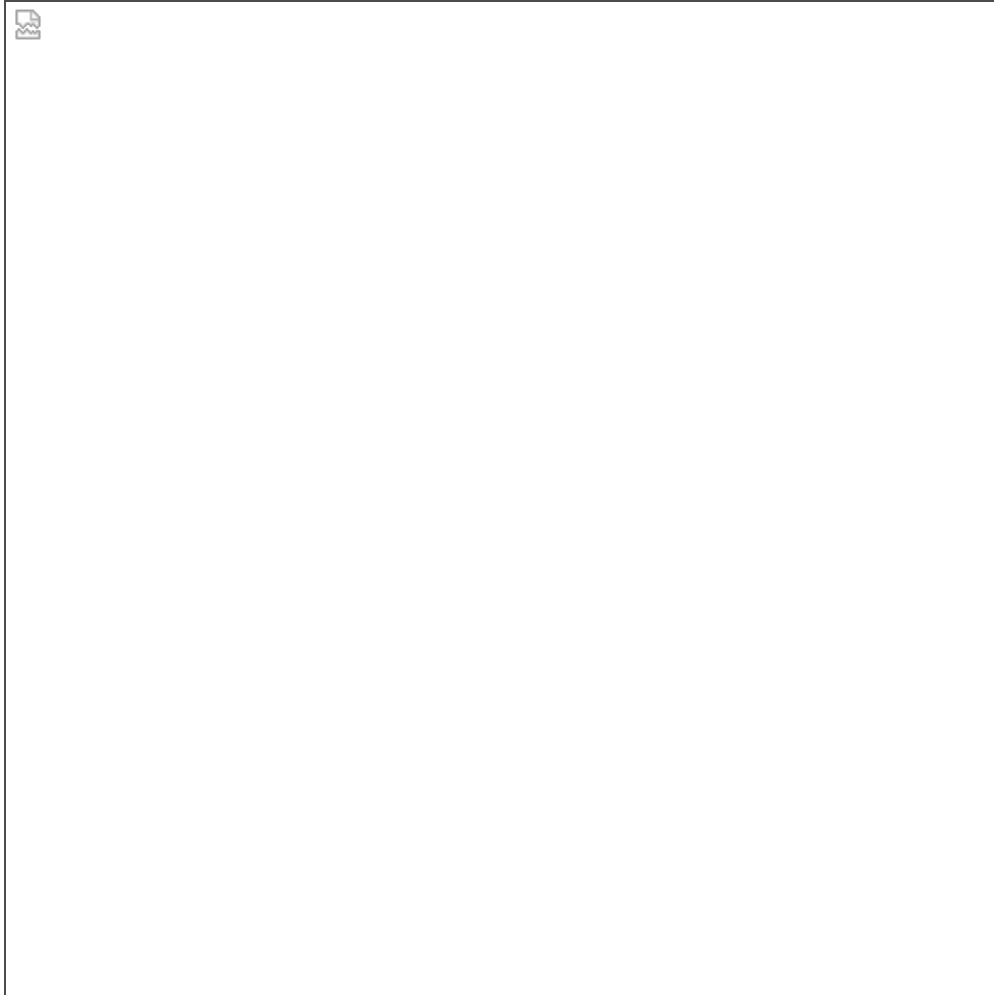

GOVERNANCE TIPS

Supports for Good Governance

By the time of adoption, Vermont's new Governance Standards will be well vetted by board members, administrators, state policy makers, and the general public. They will not be the be all, end all of good governance, but they will provide an essential starting place. Be thinking about the three main areas—Priorities, Protocols, and Processes. Consider:

1. Are your board's priorities clear, shared, and known throughout the district?
2. Do you have a recently reviewed or adopted written board operating protocol that supports the board's work? and
3. Are your board's processes clear, predictable, and known throughout the district?

Reflection and attention to these three foundational areas of governance will keep your board focused on the things that matter most.
