Hi Larkin,

TA Services for Cycle 3 Continuation Funding were backed out by TEA. Did the district budget the \$90K you reference on top of the grant budget reduced by the TA service amount? Please see the explanation below.

The district was awarded \$850K. The total award minus the 15% TA Fee would total $\$850K - \$127,500 = \$722,500$ as the amount it can spend. If they budgeted \$90K for TA Services out of \$722,500 then yes, they may reallocate those funds because the TA Fee has already been accounted for. Please let me know if this makes sense. Happy to talk through it more.
