Standard Service Agreement

THIS SERVICES CONTRACT ("Agreement") is made and entered into by and between Moody Early Childhood Center ("School"), 1110 21st St, Galveston, TX 77550 and MAYA Consulting ("Service Provider").

1. The School agrees to engage the Service Provider and the Service Provider agrees to perform personally in a manner satisfactory to the School, the following services (**Scope of work attached**):
2. Unless discontinued earlier by the School or Service Provider, the services are to be performed on the following dates and places: **September 15th, 2018 through July 31st 2020, at Galveston, Texas.**
3. For services rendered, the School agrees to pay Service Provider: **\$200,000 in monthly payments of \$8,333.**
4. Upon approval by the Texas, Education Agency, this contract may be terminated by the School or Service Provider at any time without cause and without penalty to the School or Service Provider. In the event of termination by the School or the Service Provider prior to completion of the contract, compensation shall be prorated on the basis of hours actually worked, and the Service Provider shall provide a prompt refund to the School of any funds received prior to work completed.
5. Service Provider may not assign this contract to a third party without consent of the School.
6. The Service Provider is not an employee of the School, is not entitled to fringe benefits, pension, workers' compensation, retirement, etc. The School shall not deduct Federal Income Taxes, FICA (Social Security), or any other taxes required to be deducted by an employer, as this is the responsibility of the Service Provider.
7. The Service Provider agrees to hold the School harmless from any and all liability incurred by the School by reason of the Service Provider's negligence or breach of contract including, without limitation, damages of every kind and nature, out-of-pocket costs and legal expenses.
8. The Service Provider agrees to comply with all state, federal and local laws, to the extent applicable to the services, including but not limited to FERPA (Family Educational Rights and Privacy Act), and the Equal Employment Opportunity Act. The Service Provider shall maintain all licenses and certifications required for performance of the services, as applicable.
9. The Service Provider shall retain any data, research, papers, and records, which are directly pertinent to this contract, and shall make such materials available for examination by the School, for the term of the contract and for a period of five years thereafter.
