Yesterday a group of n ne Texas representat ves sent a letter to all school board pres dents that grossly m srepresents the content of the legal FAQ as well as an naccurate t mel ne on our dec s on to leave the Nat onal School Boards Assoc at on

t's mportant that you understand the facts espec ally since this same group of lawmakers is unfortunately using both misinformation and disinformation to call on Texas school boards to leave TASB

F rst of all TASB d d not just release "legal gu dance or gu del nes" related to transgender pol c es n schools as cla med Rather we updated a legal FAQ wh ch s not a b nd ng d rect ve for school d str cts and s mply outl nes Texas laws and nat onal court dec s ons that m ght we gh nto local d str ct dec s ons on th s ssue Th s legal FAQ had been onl ne s nce 2015 and was updated n early January to reflect a case out of the Eleventh C rcu t n December

More mportantly this FAQ does not encourage school districts to refrain from reporting child abuse and to obscure information from parents

n fact the FAQ does the follow ng

- t encourages d str ct off c als to seek legal adv ce
- t encourages d str cts to work closely with parents and students to find individual zed reasonable solutions that protect students' safety ip rvacy and wellbeing in the educational environment
- t c tes the Texas Attorney General's gu dance about parental r ghts tw ce n the document
- t c tes and repeats the law on report ng ch ld abuse verbat m clearly not ng that "a person hav ng reasonable cause to bel eve that a ch ld's phys cal or mental health or welfare has been adversely affected by abuse or neglect by any person must mmed ately make a report as prov ded by Texas Fam ly Code chapter 261 "
- F nally the FAQ s fully al gned w th Texas U L rules and the "Save G rls Sports Act " TASB's legal framework at the relevant pol cy clearly says that a student must part c pate n an nterscholast c athlet c compet t on that s des gnated for the b olog cal sex stated on the student's b rth cert f cate

Those are the facts Unfortunately this letter does nothing to advance understanding of what we all know is a legally complex and evolving area of law and policy. For nearly 75 years TASB has been committed to providing resources and services to school boards with the goal of strengthening public education. Sadly there are some who are trying to weaken our schools and our communities with intentional misrepresentations. Divisive Washington style politics has no place in Texas public schools. As your executive director is will always correct and clarify false information so that you have all the facts.


