Dear Board Presidents

I am writing to set the record straight on an FAQ updated recently by TASB Legal Services on Legal Issues Related to Transgender Students

Yesterday a group of nine Texas representatives sent a letter to all school board presidents that grossly misrepresents the content of the legal FAQ as well as an inaccurate timeline on our decision to leave the National School Boards Association

It's important that you understand the facts especially since this same group of lawmakers is unfortunately using both misinformation and disinformation to call on Texas school boards to leave TASB

First of all TASB did not just release "legal guidance or guidelines" related to transgender policies in schools as claimed. Rather we updated a legal FAQ which is not a binding directive for school districts and simply outlines Texas laws and national court decisions that might weigh into local district decisions on this issue. This legal FAQ had been online since 2015 and was updated in early January to reflect a case out of the Eleventh Circuit in December.

More importantly this FAQ does not encourage school districts to refrain from reporting child abuse and to obscure information from parents.

In fact the FAQ does the following:

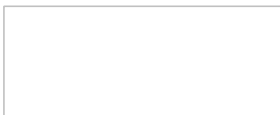
- It encourages district officials to seek legal advice
- It encourages districts to work closely with parents and students to find individualized reasonable solutions that protect students' safety, privacy, and wellbeing in the educational environment
- It cites the Texas Attorney General's guidance about parental rights twice in the document
- It cites and repeats the law on reporting child abuse verbatim, clearly noting that "a person having reasonable cause to believe that a child's physical or mental health or welfare has been adversely affected by abuse or neglect by any person must immediately make a report as provided by Texas Family Code chapter 261."
- Finally, the FAQ is fully aligned with Texas U.L. rules and the "Save Girls Sports Act." TASB's legal framework at the relevant policy clearly says that a student must participate in an interscholastic athletic competition that is designated for the biological sex stated on the student's birth certificate.

These are the facts. Unfortunately this letter does nothing to advance understanding of what we all know is a legally complex and evolving area of law and policy. For nearly 75 years TASB has been committed to providing resources and services to school boards with the goal of strengthening public education. Sadly there are some who are trying to weaken our schools and our communities with intentional misrepresentations. Divisive Washington style politics has no place in Texas public schools. As your executive director, I will always correct and clarify false information so that you have all the facts.

Finally, I want to point out that TASB did not take nearly a year to leave the National School Boards Association following its Sept. 29 letter to the Biden administration. Our Board of Directors made the decision in May following the release of an independent investigation that disclosed new details about the development of that letter. Again, facts matter, and I'm committed to always prioritizing accuracy and transparency so that TASB can continue to serve our members with excellence and integrity.
