Her request for placement of "*Irreversible Damage* by Abigail Shrier on an easel atop the shelves in the HS library" without vetting concerns me greatly. I have read mixed reviews about the book and the author; ultimately, does it pass the librarian's vetting through the policy for materials added to the collection. Should be made aware that her request for a book to be placed will go through this vetting process.

Second, I hope there is a similar vetting/validity process for calendar date additions. Just about anyone can create a special day for any topic - but I would hope that we had some criteria for date additions as calendar placement is a suggestion for instructional involvement and activities - per notes on the calendar holiday pages.

I trust our EWSD librarians will follow policy. should be made aware that there are steps to have something added or subtracted from the collection and the librarians will follow those policies and practices.
