IN 2022, WE HAD 15 SATELLITE LOCATIONS ACROSS THE VALLEY AND AS FAR NORTH AS FLAGSTAFF AND PRESCOTT WITH PLANS TO EXPAND TO COMMUNITIES IN YUMA AND TUCSON IN 2023. THESE SATELLITES ARE HOSTED IN COMMUNITY SPACES SUCH AS YMCAS OR CHURCHES AND HOLD PROGRAMS ONE DAY A WEEK.
