Memorandum of Services Rendered

This is a contract entered into by The Pennsylvania State University, Department of Asiar
Studies/The Confucius Institute and the State College Area School District on this date,
, 2014.

The State College Area School District engages The Pennsylvania State University to provide services described herein under "Scope and Manner of Services." The Pennsylvania State University agrees to provide the State College Area School District with such services in exchange for consideration described herein under "Payment for Services Rendered."

Scope and Manner of Services

Services to be rendered by The Pennsylvania State University, Department of Asian Studies/The Confucius Institute:

- Provide two University employees or graduate students to serve as Lecturers of Asian Studies to teach basic Chinese language courses to the students at the State College Area School District during the 2014-15 school year.
- University shall conduct a background check on Lecturers being provided and make sure that their educational credentials are valid prior to the start of described Services.

Compensation of Lecturer of Asian Studies

• Each Lecturer will receive a stipend of \$8,000.00 a year from The Pennsylvania State University. They will receive \$4,000.00 a semester. The State College Area School District will pay The Pennsylvania State University for one semester for each Lecturer, totaling \$8,000.00. The Pennsylvania State University, Department of Asian Studies/Confucius Institute will pay one semester for each Lecturer, totaling \$8,000.00.

Payment for Services Rendered (shared stipend)

- The State College Area School District shall pay The Pennsylvania State University, Department of Asian Studies/Confucius Institute for services rendered according to the Payment Schedule attached as Exhibit A.
- The Pennsylvania State University, Department of Asian Studies/Confucius Institute shall pay half of the assigned lecturer's stipend as is outlined in Exhibit A.
