A Summit on Math Outcomes

Invitations recently were sent for CCSSO's **2025 Legislative Conference**, March 25-27, in Washington, DC, which includes a special event, *Growing a Nation of Problem-Solvers: A Summit on Math Outcomes*. While the Legislative Conference is an invitation—only event, the summit will be livestreamed and open to the public. The summit will be held from 1-4:15 p.m. EDT on March 26. If you are not attending the Legislative Conference, consider watching the livestream of the Math Summit. We also encourage you to invite others in your state who may be interested in joining the summit online. Please share this <u>registration link</u> with them.

The summit will dig into the implementation of the evidence-based key actions in CCSSO's report, *A Nation of Problem-Solvers: How State Leaders Can Help Every Student Achieve in Math*. Attendees will hear from a mix of chief state school officers, industry leaders and other experts to engage in an exchange of ideas on the state role in improving student outcomes in math.

Trump Administration Updates

President Donald J. Trump was sworn into office as the 47th President of the United States on January 20, 2025. Here are updates on orders this week and further analysis.

Appointments: President Trump nominated former state chief and CCSSO Board member Penny Schwinn as Deputy Secretary of the U.S. Department of Education (ED). On Jan. 22, Schwinn's nomination was formally sent to the U.S. Senate. A confirmation hearing has not yet been scheduled for U.S. Secretary of Education nominee Linda McMahon or Schwinn. On Jan. 23, ED announced several senior-level appointees. See the full list here.

Executive Orders: President Trump has signed a series of executive orders. Here is a memo that outlines the executive orders related to and/or impacting education. These executive orders task the U.S. Department of Education and other federal agencies with specific next steps. ED announced on Jan. 23 it has taken action aligned with President Trump's executive order, Ending Radical and Wasteful Government DEI Programs. We anticipate more information coming from the Department of Education to outline steps it will take aligned with the other executive orders and if they will impact state education agencies or federal grants.

DHS Directive: The acting secretary of the Department of Homeland Security (DHS) rescinded federal guidance that deemed schools a "sensitive location" or "protected area" federal immigration authorities should avoid or must obtain prior approval before conducting immigration activities. (See 2021 guidance here.) DHS issued a statement on the directive here. Some states have released guidance to local districts in response to this directive. CCSSO prepared an FAQ to address some questions we have fielded from states. CCSSO also compiled guidance released by state education agencies this week, for your reference.
