To Whom It May Concern:

This is a federal civil rights complaint pursuant to the U.S. Department of Education's (Department) Office for Civil Rights' (OCR) discrimination complaint resolution procedures.

Defending Education (DE) brings this complaint against Princeton University for discrimination on the basis of sex in programs or activities that receive federal financial assistance in violation of Title IX of the Education Amendments of 1972 (Title IX), 20 U.S.C. § 1681 *et. seq.*

DE brings this complaint as an interested third-party organization with members who are parents of students throughout the country. DE and its members oppose, among other things, discrimination on the basis of sex in America's K-12 schools and institutions of higher education. Title IX prohibits discrimination based on sex in any education program or activity receiving federal financial assistance. This includes female students' rights to sex-segregated intimate spaces.¹

Princeton University is older than the United States of America. It has a history not only of academic excellence, but also of a commitment to human equality.² Princeton's sixth president, for example, signed the Declaration of Independence;³ and Princeton counts two United States Presidents and twelve Supreme Court justices among its alumni. This rich history only makes Princeton's violation of Title IX all the more tragic.

Princeton University offers 250 gender-inclusive restrooms, boasts all-gender dorms, and prescribes hormone replacement therapy to students—despite federal law and federal directives to the contrary. Astonishingly, Princeton also offers two distinct graduation ceremonies: 1) a "Rose Graduation" ceremony, "celebrating women and fem accomplishments and achievements," and 2) a "Lavender Graduation" ceremony "celebrating queer and trans accomplishments and achievements." 5

Princeton admits that Title IX prohibits discrimination on the basis of sex,⁶ but Princeton's Office of Institutional Equity and Diversity equates sex discrimination with "[s]ex or gender discrimination." Gender identity discrimination is not the same as sex discrimination under Title IX, and the Supreme Court has never held otherwise. Nevertheless, Princeton has prioritized some students' subjective feelings over all female Princeton students' rights to sex-segregated intimate spaces. Princeton takes great pride in this, writing on the landing page for its "Gender Sexuality Resource Center" that, "[s]ince the early 2000s, members of the Princeton University administration have been working to improve services and support for transgender students as well as streamline processes to make the experience easier for those who want to access any kinds of medical transition. Princeton is considered a leader among colleges and universities for our support for transgender students and was featured in the Advocate as a Top 10 Trans-Friendly University."

Princeton's bathroom policy for two residential colleges, Yeh College and New College West, appears to violate Title IX. It also violates Presidential Executive Order 14168 regarding sex discrimination in federally funded programs; ¹⁰ and it contravenes this Department's stakeholder guidance on Title IX and the prevention of sex discrimination in federally funded programs. ¹¹

Yeh College and New College West each house roughly 500 students; ¹² and Princeton forces them to share "gender-neutral" bathrooms. These bathrooms have "multiple showers and toilet stalls," and "[r]esidents

walk through a common restroom space to enter said stalls." Princeton lists this "gender neutral restroom" arrangement on the webpage of each dormitory associated with either Yeh College or New College West. 14

First-year Princeton students cannot "opt out" of the communal bathroom arrangement because Princeton "randomly assign[s]" first-year students to one of seven residential colleges. ¹⁵ As a result, Princeton forces female students to use "communal bathroom stalls [that] have gaps, which makes using them feel less safe and private," and which creates situations where female students "wal[k] in on guys literally peeing standing up with the door open." ¹⁶

Princeton offers limited exemptions from the communal bathrooms, but only for medical or safety reasons, and it cannot accommodate all requests. Moreover, while Princeton offers these medical and safety exceptions, it refuses to grant religious exemptions. This discriminates against many female religious Princeton students, such as hijabi students, whose faith regulates interactions with male students in private spaces.¹⁷

Understandably, many female students have protested these bathroom policies. As one student put it in The Daily Princetonian, "knowing that there are male students in a place that I've always considered a safe haven scares me." Another student article emphasized that "having the option to be surrounded by" only female students "would be really nice and less stressful." A third female student concluded: "[N]o student should have to share a bathroom with the opposite [sex] if they do not feel comfortable doing so." Yet Princeton forces female students to do exactly that.

In short, the reality of biological sex is a fiction at Princeton University.

Parents of Princeton students have also objected to the arrangement. Defending Education recently received a copy of an email (Exhibit A) between a Princeton parent and Princeton's Associate Dean of Undergraduate Students. The email describes the bathroom arrangement in New College West, along with the parent's objections (on religious and safety grounds) to her daughter's living arrangement. The Associate Dean acknowledges the bathroom policy's existence and says he informed the University of the parent's concerns, but the Associate Dean ultimately took no action to change the policy.

The Education Department's own guidance on Title IX clarifies that covered educational programs and activities include: "[A]ll the operations of a school that receives financial assistance.... Title IX applies to all operations of a school, including those that take place in the facilities of the school, on a school bus, or in a class or training program sponsored by the school at another location."²¹

Princeton's policies appear to violate Title IX. Accordingly, we ask that the Department promptly investigate all the allegations in this complaint, act swiftly to remedy unlawful policies and practices, and order appropriate relief.

Dear Dean for Student Life,

My daughter is a Princeton Class of 2029 student residing in Kangi Hall, New College West. I want to express my concern regarding the all-gender bathrooms, which I found on the second floor during move-in day. At that time, I saw a sign with only sink, toilet, and shower on the wall next to the bathroom door. I walked the entire floor but could not find a bathroom with a sex-specific sign. I was very shocked by the bathroom arrangement at Kangi Hall, New College West.













I understand that NCW is an all-gender residential college, but it's not right to create all-gender bathrooms for students who are still young adults. Allowing all-gender bathrooms in a residential college can lead to various issues:

- Privacy Concerns: As a mother, I don't want my daughter to be forced to use allgender bathrooms, which are places for confidential activities like changing or using the restroom.
- Safety Concerns: No one can really guarantee that inappropriate behavior or misuse of shared bathrooms won't happen. I keep telling my daughter to be extra careful when she uses these bathrooms, especially knowing that women have been victimized in bathrooms all over the country.
- Cultural and Religious Beliefs: Our family's cultural background and religious beliefs do not accept gender-mixed bathrooms. God created man and woman, and He requires us to follow His design. Men and women are different; each gender should respect and honor













each gender should respect and honor the other. Using single-sex spaces is a way to show respect for these differences.

Earlier this year, the federal government explicitly stated that it recognizes only two sexes—male and female. Efforts to deny the biological reality of sex directly threaten women's dignity, safety, and well-being. As long as Princeton University receives federal funding, it has a responsibility to comply with these federal requirements.

While I understand it may be difficult to eliminate all-gender bathrooms this school year, I hope the university will consider changing this arrangement for the next academic year. Please raise this concern with the appropriate officials. I believe that parents have the right to report such issues to the Department of Education if they are not properly addressed.

Lastly, adding a sex-specific sign to the bathroom is common sense. I believe that a prestigious university like Princeton would




